SUMMARY

Recommendation to accept a Children's Justice Act grant from State of Nevada, Division of Child and Family Services in the amount of [\$53,950; no county match required] retroactive from July 1, 2020 through June 30, 2021; direct the Comptroller's office to make the necessary budget amendments.

PREVIOUS ACTION

On August 27, 2019, the Board of County Commissioners accepted item 7.K.2, the Department's request to accept Children's Criminal Justice Act funds for July 1, 2019 through June 30, 2020.

On September 25, 2018, the Board of County Commissioners accepted item 6.K.4, the Department's request to accept Children's Criminal Justice Act funds for July 1, 2018 through June 30, 2019.

On September 27, 2016, the Board of County Commissioners accepted item 8.C, the Department's request to accept Children's Criminal Justice Act funds for July 1, 2016 through June 30, 2017.

BACKGROUND

The State of Nevada Division of Child and Family Services awards federal Children's Justice Act (CJA) funding to assist qualifying agencies in developing, establishing, and operating programs designed to improve the assessment and investigation of suspected child abuse and neglect cases including child sexual abuse and neglect-related fatalities; the investigation of cases of suspected child abuse and neglect, including child sexual abuse and exploitation; and, the assessment and investigation of cases involving children with disabilities or serious health-related problems who are suspected victims of child abuse or neglect.

Retroactive approval is requested as the notice of subaward (NOSA) was received July 23, 2020.

GRANT AWARD SUMMARY

Project/Program Name: Children's Justice Act

Scope of the Project: Provide child protection workers and stakeholders with appropriate technology and front end specialty, discipline-specific and advanced training.

Benefit to Washoe County Residents: The benefit to residents will be well-trained staff with expanded and more developed skills and resources to meet the needs of child victims.

On-Going Program Support: CJA funding continues to be an ongoing source of support for areas within the Department. This funding serves as an enhancement to ongoing efforts.
