### **SUMMARY**

Senior Services receives numerous generous donations throughout the year that assist in providing services. Donations supplement the Department's grants and contracts that serve Washoe County's growing senior population, and are brought to the Board for acceptance.

#### **PREVIOUS ACTION**

The Board approves donations received by the Human Services Agency on a regular basis.

#### **BACKGROUND**

The following donated items have been received for the time period July 1, 2020 through July 31, 2020 and will need to be retroactively accepted:

- Fans (138) received by Human Services Agency Senior Services by various donors estimated market value of \$3,450.00.
- Clothing and Laptop received by Human Services Senior Services by Soroptimist of Washoe County – estimated market value of \$300.00
- Cleaning supplies received by Human Services Agency Senior Services by a local church donation drive—estimated market value of \$1,672.75
