

AMENDMENT #2

TO SENIOR NUTRITION SERVICES AGREEMENT

THIS AMENDMENT #2 TO THE ORIGINAL AGREEMENT between the County of Washoe, a political subdivision of the State of Nevada (COUNTY) and Elior North America dba Valley Services, Inc. (ORGANIZATION) originally effective October 1, 2019 is made to revise the AGREEMENT as follows:

TERM

The initial term of Amendment #1 to Senior Nutrition Services Agreement for Provision of Meals for Our Place Women's Shelter ("Amendment #1") shall be effective from June 1, 2020 through September 30, 2020, with the option to renew for four (4) one (1) year periods, contingent upon funding; or until the original Agreement, effective October 1, 2019, is terminated pursuant to Sections 10.i and 19, whichever date shall first occur.

9. COMPENSATION

Payment. During the term of this Agreement and subject to all terms and conditions set forth herein, the COUNTY shall reimburse Valley Services, Inc. up to \$1,387,604.00 (One Million Three Hundred Eighty-Seven Thousand Six Hundred Four Dollars).

During the initial term of the Agreement (October 1, 2019 through September 30, 2020), the COUNTY shall reimburse Valley Services, Inc. an additional \$300,000.00 (Three Hundred Thousand Dollars) due to an increased demand for home-delivered meals as a result of the COVID-19 pandemic. This additional \$300,000.00 will not be considered when calculating the base price for future contract renewals or annual increases under Section 9.a.

Payment for Amendment #1. During the initial term of Amendment #1 and the first one (1) year renewal period thereafter (June 1, 2020 through September 30, 2021), and subject to all terms and conditions set forth in Amendment #1, the COUNTY shall reimburse Valley Services, Inc. up to \$270,000.00 (TWO HUNDRED SEVENTY THOUSAND DOLLARS) for the services to the Our Place Women's Shelter referenced in Sections 4.x and 4.y at the rates specified in Section 9.n. For subsequent one (1) year renewal periods, and subject to all terms and conditions set forth in Amendment #1, the COUNTY shall reimburse Valley Services, Inc. up to \$270,000.00 (TWO HUNDRED SEVENTY THOUSAND DOLLARS) for the services to the Our Place Women's Shelter referenced in Sections 4.x and 4.y at the rates specified in Section 9.n.

ALL OTHER TERMS AND CONDITIONS OF THE ORIGINAL AGREEMENT AND AMENDMENT #1 SHALL REMAIN UNCHANGED.
