Budget Narrative for Washoe County Funds Budget FY 2020

1. Personnel Costs

Covers all or a portion of salaries and fringe benefits for employees with a University of Nevada, Reno (UNR) home department of Cooperative Extension Northern Area-Washoe County. These positions include faculty, staff, and temporary employees that are providing direct programming or administrative support in the Washoe County office.

2. Travel

Covers mileage reimbursement, in-state, and out of state travel expenses related to Washoe County programs.

3. Operating Expenses

Covers all operating expenses that are not included in the Overhead Expenses category. This would include office supplies, postage, copy/binding, fingerprinting, and other miscellaneous expenses. Many computers need to be replaced before December 31, 2019 because of the end of Windows 7 support.

4. Overhead Expenses

Covers leases for building and equipment, utilities, and phone costs.

5. Equipment

No equipment purchases in FY 2019.

6. Capital Improvements

No capital improvements in FY 2019.

7. Contingency Fund

This provides a reserve for unexpected conditions, such as a sudden drop in revenues. Grant revenues are extensive and the grant funding for key programs, such as Radon Education and Literacy, may unexpectedly disappear or be greatly reduced. This fund is also used to back-up risk accounts for Sponsored Projects for Washoe County programs where funding is awarded but the fully executed award document isn't in place yet. UNR allows risk accounts to enable the charging of allowable project costs during grant award processing as long as the requesting department has discretionary funds to guarantee the requested risk account budget. Holly Gatzke, the permanent Northern Area Director/Washoe County Extension Educator, was hired 1/14/2019. She will work with Washoe County Commissioners to utilize the funds that exceed a reasonable reserve in ways that benefit the Washoe County community. Proposed plans will be presented in a January County commission meeting
