  - **SUBJECT:** Recommendation to accept a U.S. Department of Health and Human Services, Health Resources and Services Administration subgrant award from Zero to Three: National Center for Infants, Toddlers and Families in the amount of [\$75,000; no County match requirement]; retroactive from September 30, 2020 through September 29, 2021 to support the Safe Babies Court Team program; authorize the Director of the Human Services Agency to execute subaward agreement and related documents; and direct the Comptroller to make necessary budget amendments. #### **SUMMARY**

The Agency would like to recommend the acceptance of a U.S. Department of Health and Human Services, Health Resources and Services Administration subgrant award from Zero to Three: National Center for Infants, Toddlers and Families in the amount of [\$75,000; no County match required] retroactive from September 30, 2020 through September 29, 2021. This grant will support enhanced services for families participating in the Human Services Agency's Safe Babies Court Team program.

County Priority/Goal supported by this item: Safe, Secure, and Healthy Communities.

#### PREVIOUS ACTION

None

#### **BACKGROUND**

Funds for this subaward originated with the U.S. Department of Heath and Human Services, Health Resources and Services Administration (HRSA). Zero to Three: National Center for Infants, Toddlers and Families (ZTT) was awarded \$9,948,026 by HRSA to expand capacity and drive improved outcomes for very young children and families involved with the child welfare system as well as dependency and family treatment court. Funds were awarded to Washoe County Human Services Agency (HSA) to expand and enhance HSA's Safe Babies Court Team (SBCT) program. SBCT serves children birth to three years of age who have been removed from their home, and their families. This ZTT subaward will enable HSA to provide enhanced mental health and substance abuse assessments and treatment opportunities for parents as well as increased one-on-one parent mentorship, both of which will lend to improved reunification outcomes.

The Agency received the subaward contract for this grant on September 4, 2020. As such, this item will go before the Board of County Commissioners after the contract start date of September 30, 2020; therefore, the request to accept this subaward is retroactive.

#### GRANT AWARD SUMMARY

Project/Program Name: Safe Babies Court Team

**Scope of the Project:** This project will enable HSA to contract with a mental health and substance abuse services provider to provide assessments and outpatient treatment to SBCT parents, as well as contract with a parent mentor provider to provide one-on-one mentoring and support to SBCT parents.

**Benefit to Washoe County Residents:** This program will provide an enhanced experience for parents participating in SBCT, which will promote more timely reunification, improved family health and function, and reduced risk of future encounters with the court system.

**On-Going Program Support:** This funding serves as an enhancement to ongoing efforts. Funding will be pursued to continue these enhancements; however, if additional funding is not identified by the conclusion of this grant period, the program would be scaled back to eliminate these enhancements.
