grant to the District Attorney's Office in the amount of [\$76,800; \$19,200 required match], from the State of Nevada Department of Health and Human Services Division of Children and Family Service (DCFS) to provide funding to create two intermittent hourly Program Assistant positions, as approved by the Job Evaluation Committee, to coordinate victim services; retroactive from July 1, 2020 through July 30, 2021; direct

Human Resources to create the necessary positions and direct the

Comptroller to make the necessary budget amendments and retroactively authorize the District Attorney or his designees to sign the grant agreement.

## **SUMMARY**

The Washoe Board of County Commissioners must accept grant awards and must approve amendments to the adopted fiscal year budget and direct the Comptroller's Office to make necessary budget amendments.

The District Attorney's Office has received funding from the Victims of Crime Act (VOCA) grant through the State of Nevada Department of Health and Human Services Division of Children and Family Service (DCFS). This grant provides direct victim services in Washoe County. The funding will create two intermittent hourly Program Assistant positions. One will coordinate the Domestic Violence High Risk Team. The second position will coordinate community response to sexual assault and human trafficking in Washoe County.

Award is retroactive to July 1, 2020. This is the first BCC meeting date after award documents were completed.

#### PREVIOUS ACTION

On July 14, 2020, The Board accepted a Victims of Crime Act (VOCA) grant to the District Attorney's Office in the amount of [\$627,000; \$156,750 required match], from the State of Nevada Department of Health and Human Services Division of Children and Family Service (DCFS) to provide funding to retain a full-time Victim Witness Advocate and two intermittent hourly Victim Witness Advocates; retain an intermittent hourly

Forensic Interviewer and create a second intermittent hourly Forensic Interviewer and a full-time Forensic Interviewer for the Child Advocacy Center (CAC); create a full-time Human Services Support Specialist II for the CAC (as evaluated by the Job Evaluation Committee); provide for counseling services at the CAC; fund related travel, training equipment, and direct victim services and supplies; retroactive from July 1, 2020 through July 30, 2021; direct Human Resources to create the necessary positions and direct the Comptroller to make the necessary budget amendments and retroactively authorize the District Attorney or his designees to sign the grant agreement.

On June 16, 2020, the Board accepted an Amended Notice of Subaward for the 2020 Victims of Crime Act (VOCA) grant to the District Attorney's Office in the amount of [\$34,027; \$8,507 required match], from the State of Nevada Department of Health and Human Services Division of Children and Family Service (DCFS) to provide counseling services from July 1, 2019 through June 30, 2020. Direct the Comptroller to make the necessary budget amendments and retroactively authorize the District Attorney or his designee to sign the grant agreement. This award represents the remaining 50% of total FY2020 award.

On that same date, the Board accepted an Amended Notice of Subaward for the 2020 Victims of Crime Act (VOCA) grant to the District Attorney's Office in the amount of [\$154,430; \$38,608 required match], from the State of Nevada Department of Health and Human Services Division of Children and Family Service (DCFS) to provide for intermittent-hourly Victim Witness Advocate and Forensic Interviewer positions as approved by the Job Evaluation Committee; from July 1, 2019 through June 30, 2020. Direct Human Resources to create the necessary positions and direct the Comptroller to make the necessary budget amendments and retroactively authorize the District Attorney or his designee to sign the grant agreement. This award represents the final 50% of total FY2020 award.

Lastly, on that same date the Board accepted an Amended Notice of Subaward for the 2020 Victims of Crime Act (VOCA) grant to the District Attorney's Office in the amount of [\$98,295; \$24,574 required match], from the State of Nevada Department of Health and Human Services Division of Children and Family Service (DCFS) to provide funding for an existing part-time Victim Witness Advocate and a new intermittent-hourly Victim Witness Advocate position as approved by the Job Evaluation Committee, along with related travel, equipment, and victim services; from July 1, 2019 through June 30, 2020. Direct the Comptroller to make the necessary budget amendments and retroactively authorize the District Attorney of his designee to sign the grant agreement. This award represents the remaining 50% of total FY2020 award.

Please note that in FY2020, the District Attorney's Office received three (3) VOCA grants which were each dispersed in 3 segments each which consisted of 10%, 40%, and then the final 50%.

The Board has accepted VOCA grants on behalf of the District Attorney's Office since 2003.

## **BACKGROUND**

The Domestic Violence High Risk Team (DVHRT) Program Assistant will be responsible for the development, implementation, and coordination of a Washoe County *Domestic Violence High Risk Team*. The DA has a long-term goal of establishing a coordinated community response to domestic violence in Washoe County. This position will establish a DVHRT based on an innovative strategy to prevent domestic violence and homicides that is grounded in research. The DA has been laying the foundation for the development of a DVHRT based on this model - which enables agencies to customize their DVHRT so that it functions within the policy and statutory mandates of their respective jurisdiction. The DA believes the establishment of a DVHRT will positively impact victim safety, offender accountability and the DV response system in Washoe County.

The Sexual Assault/Human Trafficking (SA/HT) Program Assistant will be responsible for providing a coordinated community response to sexual assault and human trafficking in Washoe County. This will include the coordination of the Sexual Assault Response Team (SART), as well as all medical and forensic examinations and services required to meet the patient load of the SART and Child Abuse Response and Evaluations (CARES) programs. Since victims of SA and HT may be as young as 13 years old, the proposed Coordinator will also coordinate services through CARES. The SA/HT Coordinator will play a critical role in Washoe County, serving as a liaison between the WCDA's Office and hospitals, non-profit agencies and law enforcement agencies to generate a coordinated response team to meet the needs of adolescent and sexual assault survivors.

These positions were approved by the Review Committee on 8/5/2020 and the Job Evaluation Committee on 8/18/2020.

Award is retroactive to July 1, 2020. This is the first BCC meeting date after award documents were completed.
