AMENDMENT #3 TO AGREEMENT FOR

OUR PLACE WOMEN AND FAMILY SHELTER OPERATOR

WHEREAS Washoe County has determined the need to expand shelter services at the Our Place Campus using Building 8B, this AMENDMENT #3 to the ORIGINAL AGREEMENT between the County of Washoe, a political subdivision of the State of Nevada (COUNTY) and Reno Initiative for Shelter and Equality ("OPERATOR" or "RISE") originally effective May 1, 2020 is made to revise the AGREEMENT as follows:

- A. Increase RISE staffing and services to accommodate the addition of clients and families into Building 8B on the Our Place Campus; and
- B. Add \$150,000 (ONE HUNDRED FIFTY THOUSAND DOLLARS) to the FY21 AGREEMENT term to support additional RISE staffing needed in Building 8B for the remaining portion of the FY21 AGREEMENT period; and
- C. Add \$300,000 (THREE HUNDRED THOUSAND DOLLARS) to the future renewal periods beginning with the FY22 annual term to support additional RISE staffing needed in Building 8B for the entire annual renewal period.

THEREFORE, the following contract sections are amended as follows:

Section 3 Compensation is hereby amended to increase the FY21 total not to exceed amount from \$2,103,333 (TWO MIILLION ONE HUNDRED THREE THOUSAND THREE HUNDRED THIRTY-THREE DOLLARS) up to \$2,253,333 (TWO MILLION TWO HUNDRED FIFTY-THREE THOUSAND THREE HUNDRED THIRTY-THREE DOLLARS) through June 30, 2021.

Subsequent renewal periods shall be increased from a total not to exceed of \$1,820,000 (ONE MILLION EIGHT HUNDRED TWENTY THOUSAND DOLLARS) up to \$2,120,000 (TWO MILLION ONE HUNDRED TWENTY THOUSAND DOLLARS) per fiscal year if contract extensions are implemented. The implementation of contract extensions shall not require a written amendment unless changes in performance or compensation are also required.

UNLESS PREVIOUSLY AMMENDED, ALL OTHER TERMS AND CONDITIONS OF THE ORIGINAL AGREEMENT SHALL REMAIN UNCHANGED. IN WITNESS WHEREOF, all parties of the AGREEMENT hereto have set theirs hands and subscribed their signatures to effect this AMENDMENT #3.
