Diesel exhaust extraction system retrofit and upgrades for 11 fire stations and 42 fire apparatus.

Air Exchange Inc. of Fairfield, CA is the only responding service provider to inquiries for service of both the Nederman and Plymovent exhaust systems. Nederman and Plymovent are currently in use at TMFR stations (Exhibit A lists which stations have Nederman and Plymovent).

Local vendors have declined or failed to respond to requests to work on the current equipment. Washoe County Building Services also declines to work on equipment. Air Exchange has specific knowledge and background as it relates to currently installed systems at TMFR stations and is the authorized dealer of Plymovent systems.

What efforts were made to determine there was no competition for the service or good and how was it determined the price for the purchase is fair and reasonable?

Consultation with Plymovent corporate headquarters revealed the next closest authorized dealer is in Los Angeles, CA followed by Denver, CO. Nederman systems dealer is in Sacramento, CA (Exhibit B) but has an inferior product that does not capture the higher percentage of exhaust like Plymovent (Exhibit C). While both systems capture exhaust, this retro fit allows for increased capture while maintaining and improving existing systems until their end of useful life.

I have read and understand the Policies and Procedures of the Board of County Commissioners including the Washoe County Grants Manual (if applicable) with regard to sole source procurements. Not exhausting the diesel fumes leaves them to be inhaled in the fire station and to settle on surfaces for touch contamination at a later time. Plymovent systems are designed for fire apparatus and drive through/away capabilities. This allows for a rapid response to emergencies while capturing harmful diesel exhaust for removal from the fire station. The product being purchased must be compatible with existing equipment. Identify the existing equipment. Current equipment is a cross between Nederman and Plymovent causing compatibility issues between apparatus and stations. Systems cannot be used at all times depending upon which apparatus are stationed or covering which station. Air Exchange Inc. has designed an approved retrofit that will bring all stations and apparatus to a fully compatible and standardized status (Exhibit D). Four of eleven stations already have Plymovent systems installed and will require minimal upgrading. 3. The product requested is one which the user has had specialized training for. Pricing quote provided was negotiated to be best available and fair pricing. Consideration was given to use of existing equipment as much as possible while retrofitting all systems to be universal across the fleet and fire stations. Rather than full replacement costs (est. \$483,000) the retrofit is \$125,000. The additional \$10,000 was to be spend outfitting 10 apparatus and under the proposal would be used to outfit 42 apparatus with the some amount of money. Air Exchange has been servicing and repairing TMFR systems for several years with little fluctuation in pricing.
