  - **SUBJECT:** Recommendation to approve a Lease Agreement between Washoe County and The Great Basin Institute to provide in-kind services [in the approximate amount of \$28,400] to the Community Services Department as consideration for lease fees for use of the resident housing at Galena Creek Regional Park and allow for a 36 month term commencing April 13, 2021 through April 12, 2024. (Commission District 1.)

#### **SUMMARY**

The Great Basin Institute (GBI), a Nevada 501 (c)(3) nonprofit organization, has been performing various in-kind services at Galena Creek Regional Park since October 2009, through the support of the Open Space and Regional Park Commission and approval by the Board of County Commissioners (Board).

The residence at Galena Creek Regional Park is being occupied by GBI as housing for staff members assigned to the operation of the Galena Creek Visitor Center (GCVC). In consideration of leasing the property, GBI has performed in-kind services, in the approximate amount of \$28,400, including running the daily operation of the Galena Creek Visitor Center, providing environmental-base community programs, and performing resource management support. In kind services are estimated considering the time the center is open, number of staff and average pay.

The Open Space and Regional Parks Commission recommended approving an agreement with GBI at their April 6, 2021 meeting.

#### **PREVIOUS ACTION**

On April 6, 2021, the Open Space and Regional Park Commission recommended approval of a lease agreement with Great Basin Institute.

#### BACKGROUND

The Galena Creek Recreation Area (GCRA) including the Galena Creek Visitor Center is located on federal land adjacent to Washoe County's Galena Creek Regional Park. Washoe County, in conjunction with the USDA Forest Service, executed a Memorandum of Understanding and Collection Agreement with the US Forest Service for construction and operations of the area including the visitor center.

Due to continued budgetary constraints and the reduction of staff in the Parks and Open Space program, staff developed a partnership program with the Great Basin Institute to provide staffing and volunteers to operate the Visitor's Center, in exchange for occupying the residence rent free.

GBI has provided in-kind services in consideration of rent for the residence at Galena Creek Regional Park since 2009. GBI has utilized the residence as housing for staff members assigned to the operation of the Galena Creek Visitor Center. The details of the in-kind services provided by GBI was negotiated and outlined in the Lease Agreement. The community benefits from the partnership and the programs offered by GBI, and staff recommends the partnership continue.

To date (with the exception of 2020/2021 and the closure of the Galena Creek Visitor Center due to COVID-19 restrictions) all of the commitments made to Washoe County by GBI, have been fulfilled, including keeping the Visitor's Center open year-round, with staff and volunteers, providing nature-based community programs, promoting retail sales and maintaining an inventory of souvenirs, books, maps, and nature oriented items and informational brochures. GBI has also complied with all obligations regarding maintenance.

GBI was considering changes to the operations of the Visitor Center that would require changes in the Lease Agreement. Specifically, GBI was trying to determine a staffing model that could be supported during the winter operations, when programming and program revenue are lower.

Therefore, staff recommends the approval of the Lease Agreement with the on-going commitment by The Great Basin Institute performing the operational tasks as identified in Exhibit A of the Lease Agreement.

## FISCAL IMPACT

Washoe County will incur expenses for the repairs and maintenance of the structures and minor costs for the heating, air conditioning and water to the premises which is included in the existing operating budget; Community Services Operations cost center 140530.

# **RECOMMENDATION**

It is recommended the Board of County Commissioners approve a Lease Agreement between Washoe County and The Great Basin Institute to provide in-kind services [in the approximate amount of \$28,400] to the Community Services Department as consideration for lease fees for use of the resident housing at Galena Creek Regional Park and allow for a 36 month term commencing April 13, 2021 through April 12, 2024.
