# Welfare of the Inmates

- ▶ Welfare of inmates in custody include these factors:
  - ▶ Health of inmates
  - ▶ Access to medical care
  - ▶ Infectious disease and vermin control
  - ▶ Food services
  - ▶ Environmental controls
  - ▶ Safety of inmates
  - ▶ Out of cell time

# Welfare of Inmates

## COVID-19 Update

- ▶ Steps taken to mitigate COVID-19 threat to jail population
  - ▶ Cancelled all in person contact with inmates
    - ▶ Increased iWeb, telephone, email access
  - ▶ Cancelled all inmate transports outside facility
  - ▶ Cancelled all inmate programming
  - ▶ COVID education campaign
  - ▶ Waived medical assessment fee
  - ▶ Creation of Isolation/Quarantine Unit
  - ▶ Created COVID-19 pre-screening station in Intake
  - ▶ Reduced tier time numbers for social distancing
  - ▶ Started testing ALL new inmates prior to being transferred to General Housing
  - ▶ Issued masks to all inmates traveling outside their assigned housing unit

# Welfare of the Inmates

## COVID - 19 Update 3<sup>rd</sup> Quarter

- ▶ Intake isolation Unit (HU 1 & 7)
- ▶ COVID-19 Quarantine Unit (HU11)
- ▶ 107 Inmates Tested
  - ▶ State of Nevada laboratory
  - ▶ Additional 100+ rapid scan tests
- ▶ 29 Total Inmates Positive for COVID-19

# Washoe County Detention Facility COVID -19 Update

- ▶ Jail Inoculation Update
  - ▶ 195 Inmate(s) Inoculated
    - ▶ 182 Janssen
    - ▶ 13 Moderna
  - ▶ 95 High Risk Inmates
    - ▶ 13 Inmates over 65 years of age

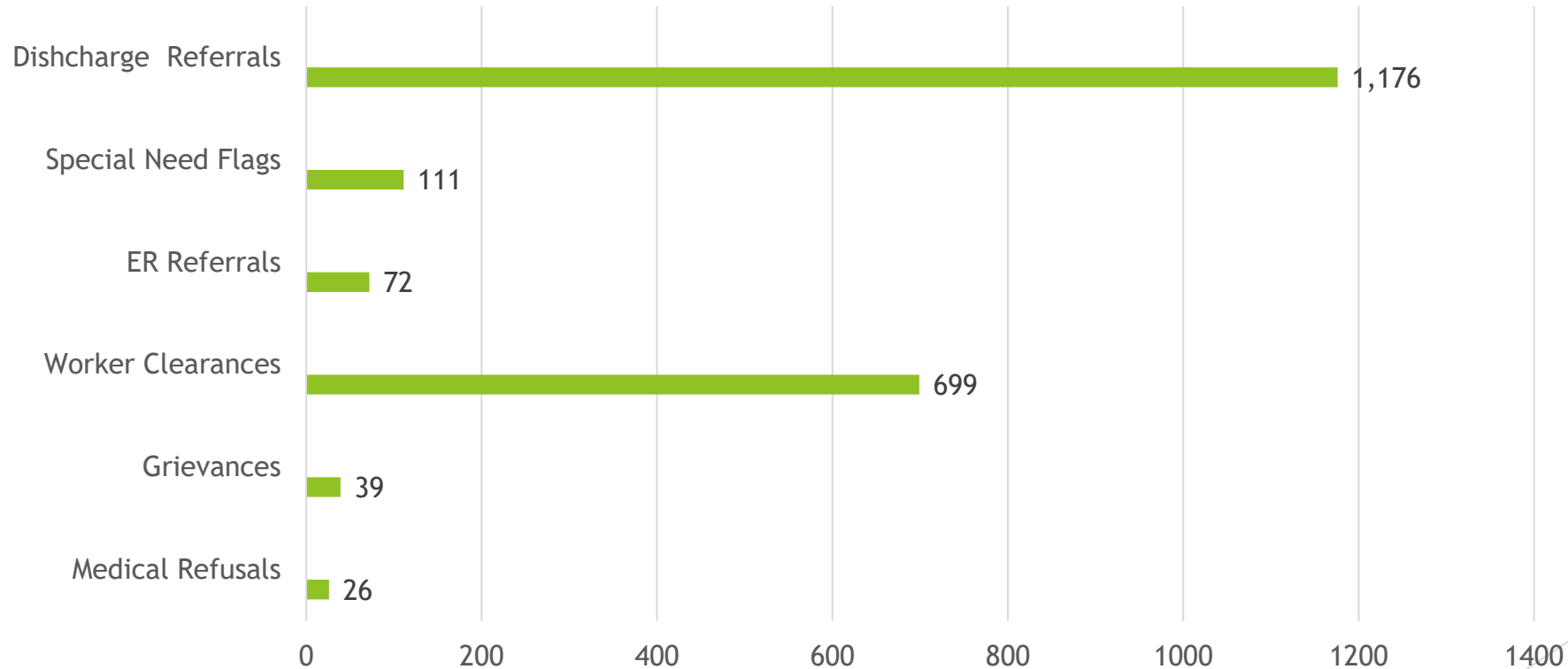

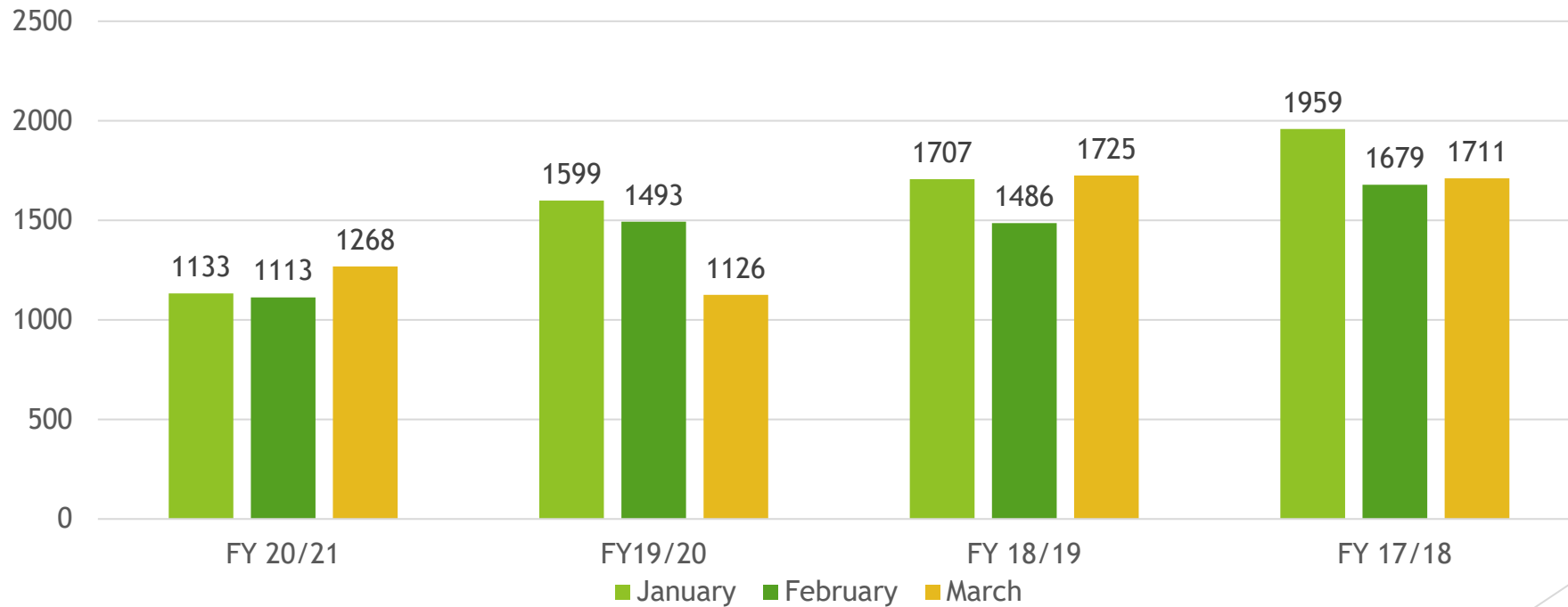
# Welfare of the Inmates

- ▶ Jail continues to see increase in mental health population
  - ▶ Housing Unit 3 and Medical Unit at capacity
    - ▶ Special Watch cells at capacity
    - ▶ Suicide attempts up 136% this quarter (11 to 26)
    - ▶ Averted attempts up 34% this quarter (206 to 277)
- ▶ Bunk Project is moving forward
  - ▶ Prototypes installed
  - ▶ Over 700 bunks to be fabricated

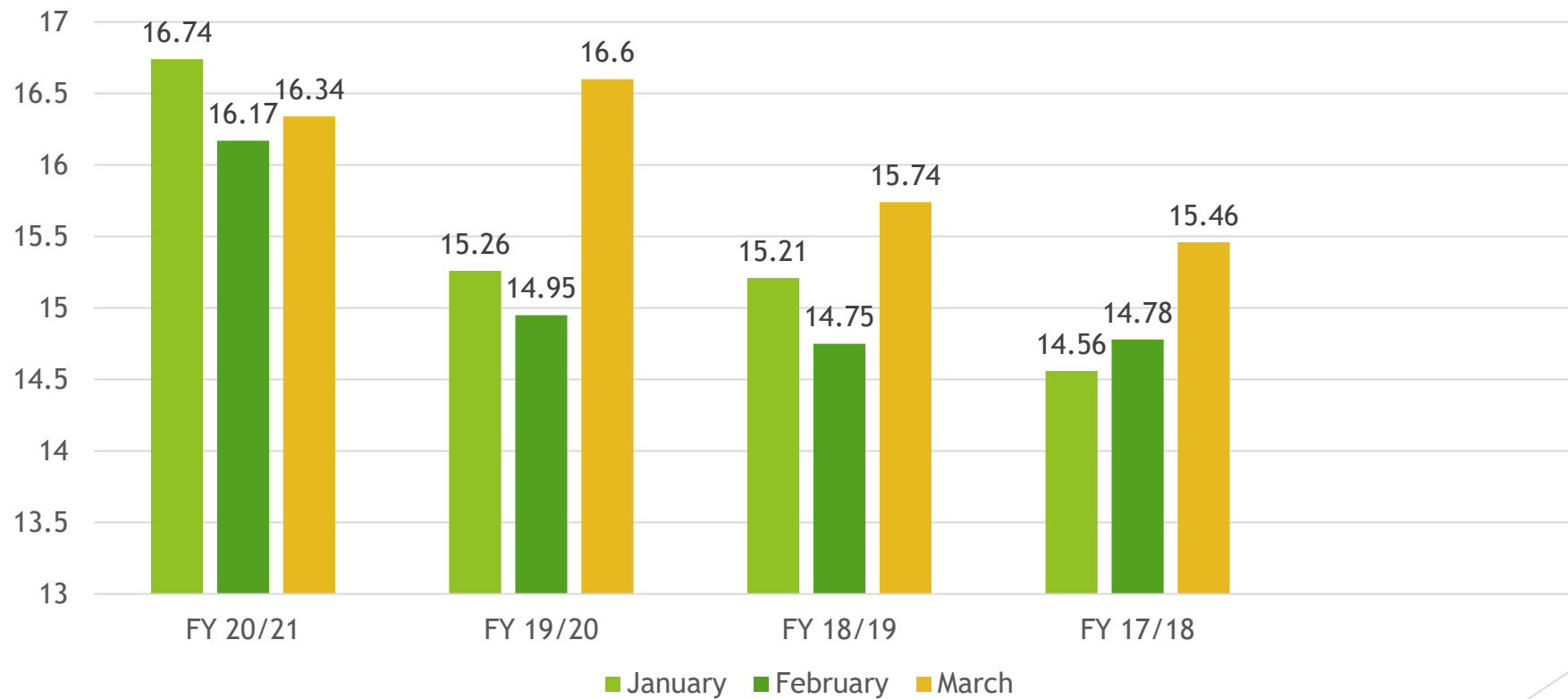
# FY 20/21 3rd Quarter Average Daily Population

## ▶ Battery by Inmate

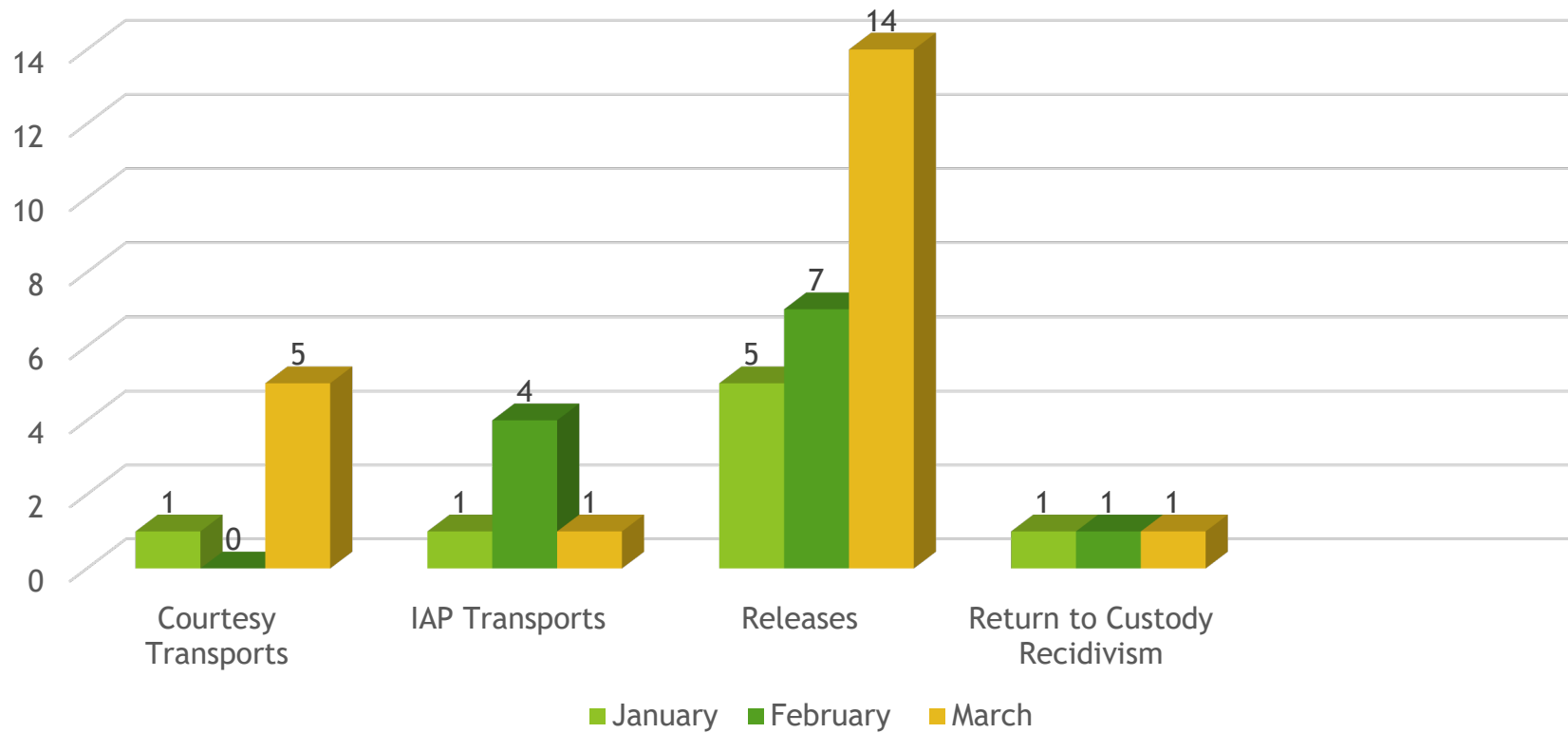
- ▶ Inmate vs Inmate - 16

# Washoe County Detention Facility

## NaphCare Medical

### ► Medical Highlights

- Contracted by Washoe County in 2016
  - Less than 30 day transition due to previous medical provider
- Increased Overall Health of Population
  - Vitamin deficiencies, special diets, advanced wound care
- Increase Mental Health Staff
  - Physician's Assistance and Psych RN and 3 part time Licensed Clinical Social Workers
- Certified Medication Assisted Treatment Program
  - DEA, Nevada, SAMSHA, CASAT/Sapta, Pending NCCHC
  - Over 100 inductions and MAT referrals leading to Subutex and/or Vivitrol treatment
  - 23 Vivitrol inductions prior to release to treatment program
- Inmate Medical Evaluation initiated at Intake

    - Electronic and Portable
  - HealthIE Nevada
    - Links Northern Nevada providers for continuity of care
    - Instant access to medical information
  - Surescript
