BACKGROUND

On May 25, 2021 the Washoe County Board of Fire Commissioners approved a Commissioner District 5 Special Fund Disbursement Donation in the amount of \$4000 in support of the Truckee Meadows Fire Protection District's volunteer programs as identified below:

- \$2,000 to the Palomino Valley Volunteer Program to support training and equipment upkeep. The Palomino Valley Volunteer Department Program is managed by the Truckee Meadows Fire Protection District.
- \$2,000 to the Silver Lake Volunteer Fire Program to support operations. The Silver Lake Volunteer Fire Department Program is managed by the Truckee Meadows Fire Protection District.

FISCAL IMPACT

The monetary donation will be deposited into the Truckee Meadows Fire Protection District Palomino Valley Volunteer Department and Silver Lake Volunteer Department Program operational budgets.
