**SUBJECT:** Recommendation to approve a direct grant award [\$5,000.00, no match required] from the United States Department of Justice, United States Attorney, Organized Crime Drug Enforcement Task Force (OCDETF) for reimbursement of overtime costs incurred while involved in the investigation of OCDETF Initiative number PA-NV-344 for the retroactive grant period of April 1, 2021 – September 30, 2021, and if approved, direct Comptroller's Office to make the necessary budget amendments. ### SUMMARY

These funds from the United States Department of Justice (USDOJ) will be used to reimburse the County for overtime expenses incurred while involved in the investigation of Organized Crime Drug Enforcement Task Force (OCDETF) Initiative number PA-NV-344.

The Washoe Board of County Commissioners must accept grant awards and must approve amendments to the adopted fiscal year budget and direct the Comptroller's Office to make the necessary budget amendments.
