## **SUMMARY**

This staff report is seeking approval to sell a surplus 2008 Pierce Contender VIN # 4P1CC01A28A008660 (FD505) Reserve Engine with 30,156 miles, in "as is" condition from the Truckee Meadows Fire Protection District to the Reno Tahoe Airport Authority Fire Department in the amount of \$1. This apparatus has reached the end of its useful life pursuant to the district's fire engine replacement schedule.

#### **BACKGROUND**

NRS 474.160(8)(a) provides that the Board of Fire Commissioners is empowered to dispose of property that the Board determines the District no longer has a need for. NRS 334.030 allows "any governmental entity to take full advantage of the available surplus properties of any other governmental entity" by allowing governmental entities to sell and buy real and personal property without the need for advertising, bidding or compliance with other similar laws, specifically noting that all other laws, "are suspended to the extent such provisions are inconsistent herewith."

It has been determined that this apparatus has reached the end of its useful life pursuant to the District's fire engine replacement schedule and will no longer be needed, in part, due to the districts recent purchase of five new Type I Engines.

This proposed sale will also assist the Reno Tahoe Airport Authority (RTAA) Fire Department with improving their reserve and first line Type I engine fleet, which is a direct benefit to the District due to

closeness in proximity between our jurisdictions for Mutual & Automatic aid assists. TMFPD & RTAA are in the process of establishing an automatic aid agreement that will provide faster and more efficient responses to and from each agency. Up until recently, the RTAA Fire Department did not have any Type I fire engines, so this apparatus will enhance the RTAA Fire Department's capabilities. This contribution of a Type I engine from TMFPD to RTAA for \$1 will benefit the District with anticipated responses that benefit the District.

## FISCAL IMPACT

In the Districts June 30, 2021, financial statements this Engine has a book value of \$140,922. The \$1 in sales proceeds will be deposited into the District's Capital Projects funds, the book value of \$140,922 will be recognized as a loss on sale of capital assets in the District's Government wide financial statements for the year ending June 30, 2022.

# **RECOMMENDATION**

It is recommended that the Board approve a motion to sell a surplus 2008 Pierce Contender VIN # 4P1CC01A28A008660 (FD505) Reserve Engine with 30,156 miles, in "as is" condition from the Truckee Meadows Fire Protection District to the Reno Tahoe Airport Authority Fire Department in the amount of \$1.
