SUBJECT: Recommendation to accept Supplemental Grant funding from the State of Nevada Department of Public Safety, Office of Criminal Justice Assistance [additional funding of \$35,806.00, for a total award of \$67,034.00, no In-Kind county match required] to cover the purchase of a UV light system, to assist with disinfection of the entire detention facility for the retroactive grant period of January 20, 2020 through December 31, 2021 and if approved, direct Comptroller's Office to make the necessary budget amendments and authorize Sheriff Balaam to execute grant award documents. (All Commission Districts.)

SUMMARY

Additional COVID Emergency Supplemental Funding has been awarded to cover the costs of a UV light system to assist with the disinfection of the entire detention facility. This equipment will assist with continuing to stop the spread of COVID-19.

Washoe County Strategic Objective supported by this item: Safe, secure and healthy communities.

PREVIOUS ACTION

On November 10, 2020, board approved item # 8.J.1. original COVID Emergency Supplemental Funding in the amount of \$31,228.00.

BACKGROUND

The Washoe County Sheriff's Office was awarded a grant with the Nevada Office of Criminal Justice Assistance to purchase new Polycom Systems for our arraignment rooms as well as a U-Temp temperature monitoring stations for the entrances to our building.

The Washoe County Sheriff's Office was given additional grant funding in the amount of \$35,806.00, which will pay for the purchase of a UV light system to assist with the
