GRANT AWARD SUMMARY

Project/Program Name: EPA PM 2.5 Monitoring Network

Scope of the Project: The PM 2.5 award provides funding for salaries and benefits, one-time funding for equipment, and indirect expenditures. For FY21, EPA provided full federal funding in the amount of \$119,249, which includes \$40,144 of EPA in-kind support. Washoe County Health District is authorized to expend the remaining \$79,105.

Benefit to Washoe County Residents: Implementation of clean air solutions that protect the quality of life for the citizens of Reno, Sparks and Washoe County.

On-Going Program Support: These funds support on-going PM 2.5 activities in the Air Quality Program.

Award Amount: Total award is \$215,948(4/1/20-3/31/22)

Grant Period: April 1, 2020 – March 31, 2022

Funding Source: Environmental Protection Agency (EPA)
