SUMMARY

Washoe County Regional Animal Services has been awarded \$3,000.00 from Maddie's Fund and Michelson Found Animals Foundation to expand their lost animal reunification efforts for dogs and cats. Funds offset the majority of the expenses of a personalized pet tag engraving machine, purchased for \$3,055.00.

PREVIOUS ACTION

BACKGROUND

Regional Animal Services' reunification efforts aim to actively reunite pets with their owners both in the field and from the shelter. While we have a return to owner success rate of 48% (one of the best in the nation), WCRAS consistently embraces new methods to improve. We participated in the "No Place Like Home Challenge" sponsored by Maddie's Fund in March 2021 and were awarded the grant in recognition of our expanded program that now offers pet owners the ability to get a custom-engraved pet tag at our shelter. In addition to microchips and dog licenses, this personalized pet tag offers an additional tool to help reunite pets with their owners.
