TO ACCEPT A GRANT AWARD FROM THE FIREHOUSE SUBS PUBLIC SAFETY FOUNDATION AND TO AMEND THE FISCAL YEAR 2021-22 BUDGET OF THE TRUCKEE MEADOWS FIRE PROTECTION DISTRICT GENERAL FUND

WHEREAS, the Board of Fire Commissioners have accepted a grant disbursement in the amount of \$30,640.00 sponsored by Firehouse Subs Public Safety Foundation, and co-sponsored by the Anita Carter Cancer Prevention Fund in support of Truckee Meadows Fire Protection District for the purpose of purchasing Two Unimac Gear Washer/Extractors, Two Gear Dryers, Bases & Accessories (Installation Included up to \$1000 & Freight Included up to \$600); and

WHEREAS, the Truckee Meadows Fire Protection District is committed to excellence, service, and the protection of life and property in the community; and

WHEREAS, we have several documented cases of current and former members of the District who have been diagnosed with fire service work-related Cancer; and

WHEREAS, there are case studies that show a direct correlation between fire service work-related Cancer and lack of proper decontamination, disinfecting, and laundering of Personal Protective Equipment (PPE); and

WHEREAS, having this equipment would benefit the District both operationally and fiscally, by increasing cleaning frequency and reducing the amount of time PPE is out of service when it is shipped to a 3rd party vendor, and costs associated with cleaning and shipping.

NOW, THEREFORE, BE IT RESOLVED that the respective Board of Fire Commissioners for the Truckee Meadows Fire Protection District does hereby recognize, accept, and authorize

Section 1. That the budget of the Truckee Meadows Fire Protection District General Fund be adjusted as follows:

Increase Revenues:

General Fund Miscellaneous Revenues: Donations and Contributions \$30,640.00

Increase Expenses:

General Fund Service and Supplies: Non-capital equipment \$30,640.00

Section 2. This Resolution shall be effective on passage and approval.

Section 3. The Washoe County Clerk is hereby directed to distribute copies of the Resolution to the Department of Taxation, Washoe County Comptroller, and the TMFPD Chief Fiscal Officer.
