SUBJECT: Recommendation to authorize the sale of a surplus 2008 Pierce Arrow Reserve Engine with approximately 115,700 miles in “as is” condition from the Truckee Meadows Fire Protection District to the City of Reno in the amount of \$95,000.00. (All Commission Districts) FOR POSSIBLE ACTION

SUMMARY

This staff report is seeking approval for authorization of the sale of a surplus 2008 Pierce Arrow Reserve Engine with 115,700 miles in “as is” condition from the Truckee Meadows Fire Protection District to the City of Reno in the amount of \$95,000.00. The apparatus has reached the end of its useful life for the District pursuant to the District’s fire engine replacement schedule.

PREVIOUS ACTION

None.

BACKGROUND

Statutory Authorization for Sale: NRS 474.160(8)(a) provides that the Board may dispose of property that the District no longer needs. NRS 334.030 allows “any governmental entity to take full advantage of the available surplus properties of any other governmental entity” by allowing governmental entities to sell and buy real and personal property without the need for advertising, bidding or compliance with other similar laws, specifically noting that all other laws, “are suspended to the extent such provisions are inconsistent herewith.”

Sale of Reserve Engine: The apparatus being sold was identified through the fleet replacement plan as needing replaced. The District recently took delivery of 5 new type 1 engines to replace aging apparatus at or nearing the end of their useful life. As the District’s current front-line engines are replaced with new engines, they move to reserve status. The oldest reserve engines, including this one proposed for sale, are no longer necessary to the District. This proposed sale will also assist Reno Fire Department with improving their reserve fire engine fleet, which is a direct benefit to the District due to the automatic/mutual aid relationship between the agencies.

FISCAL IMPACT

The current book value of this engine is \$181,962. The \$95,000 in sales proceeds will be recognized as Fiscal Year 2021-22 revenues and be deposited into the District's Capital Projects funds. A loss of approximately \$86,962 (proceeds less book value) will be recognized in the District's Government wide financial statements for the year ending June 30, 2022.

RECOMMENDATION

It is recommended the Board approve the sale of the District's surplus 2008 Pierce Arrow VIN # 4P1CA01H98A008528 (FD19) Reserve Engine with 115,700 miles in "as is" condition from the Truckee Meadows Fire Protection District to the City of Reno in the amount of \$95,000.00.

POSSIBLE MOTION
