### SUMMARY

The Juvenile Justice Program Office provides funding to assist with the treatment and programming needs of Washoe County youth under the supervision of Washoe County Department of Juvenile Services. This item is submitted for acceptance retroactively as this was the next available meeting upon receipt of award notification.

County Priority/Goal supported by this item: Coordination Between Agencies & Communication of Programs.

### PREVIOUS ACTION

On July 14, 2020, the Board of County Commissioners accepted the Community Corrections Partnership Block Grant from the Department of Health and Human Services – Juvenile Justice Programs Office in the amount of \$317,163.53 to provide treatment and programming to youth referred to the Washoe County Department of Juvenile Services; for the retroactive period of 7/1/20-6/30/21.

On July 23, 2019, the Board of County Commissioners accepted the Community Corrections Partnership Block Grant from the Department of Health and Human Services Juvenile Justice Programs Office in the amount of \$317,101.36 to provide treatment and programming to youth referred to the Washoe County Department of Juvenile Services.

On June 26, 2018, the Board of County Commissioners accepted the Community Corrections Partnership Block Grant from the Department of Health and Human Services Juvenile Justice Programs Office in the amount of \$318,663.29 to provide treatment and programming to youth referred to the Washoe County Department of Juvenile Services.

This funding was formally granted as the Specialized Foster Care Room and Board Medicaid Funding.

### **BACKGROUND**

Juvenile Services provides treatment, programming, and board and care to referred Washoe County youth. Juvenile Services assists with providing, counseling, mental health care and substance abuse treatment with funds provided by the Nevada Department of Health and Human Services – Juvenile Justice Programs Office.
