SUBJECT: Recommendation to accept a FY22 Title XX subgrant award from the Nevada Department of Health and Human Services (DHHS) in the amount of [\$663,807; no county match] retroactive from July 1, 2021 to June 30, 2022 to promote unification, safety, educational support, and normalcy for children in care; authorize the Director of the Human Services Agency to retroactively execute the grant award documents; and direct the Comptroller's office to make the necessary budget amendments. SUMMARY

The Washoe Board of County Commissioners must accept grant awards and direct the Comptroller's Office to make the necessary budget amendments.

Washoe County Human Services Agency is requesting the Board accept a FY22 Title XX subaward from the Nevada Department of Health and Human Services (DHHS) in the amount of [\$663,807; no county match] retroactive from July 1, 2021 to June 30, 2022 to provide shelter services to prevent the removal of children from their families; to provide behavioral health services to children; and to provide professional development and training opportunities to Human Services Agency staff and foster parents.

Washoe County Strategic Objective supported by this item: Safe, Secure and Healthy Communities

PREVIOUS ACTION

On November 10, 2020, the Board approved item #16, the Agency's request to accept a State of Nevada Department of Health and Human Service FY21 Title XX subgrant award in the amount of \$663,807 with no county match retroactive from July 1, 2020 to June 30, 2021.

On December 10, 2019, the Board approved item #13, the Department's request to accept a State of Nevada Department of Health and Human Services Title XX subgrant in the amount of \$663,807 with no county match retroactive from July 1, 2019 to June 30, 2020.

On August 28, 2018, the Board approved item #14, the Agency's request to accept a State of Nevada Department of Health and Human Services Title XX subgrant in the amount of \$663,807 with no county match retroactive from July 1, 2018 – June 30, 2019.

On February 27, 2018 in item 9J2, the Board accepted the Social Services Block Grant Title XX Supplemental Subgrant award from the State of Nevada, Department of Health and Human Services, Office of Community Partnerships and Grants in the amount of \$10,000 to promote reunification, safety, educational support and normalcy for children in care retroactive July 1, 2017 through June 30, 2018.

On September 12, 2017 in item 17, the Board accepted the Social Services Block Grant: Title XX subgrant award from the State of Nevada, Department of Health and Human Services, Office of Community Partnerships and Grants in the amount of \$655,775 to promote reunification, safety, educational support and normalcy for children in care retroactive July 1, 2017 through June 30, 2018.

BACKGROUND

Title XX of the Social Security Act provides for funding to states to provide locally relevant social services through the Social Services Block Grant (SSBG). States are allocated funding through a formula-based entitlement and have substantial discretion in the use of SSBG funds. Each State determines what services are provided, who is eligible to receive them, and how funds are used. The State of Nevada Department of Health and Human Services allocates these funds to state and non-state programs providing social services in urban and rural communities statewide. Through the SSBG, States provide essential social services that help achieve a myriad of goals to reduce dependency and promote self-sufficiency; prevent and protect children and adults from neglect, abuse and exploitation; and help individuals who are unable to take care of themselves to stay in their homes or to find the best institutional arrangements.

The Agency received the Notice of Award for this grant on July 15, 2021 with an effective date of July 1, 2021; therefore, the request to accept this award is retroactive.

GRANT AWARD SUMMARY

Project/Program Name: FY22 Title XX

Scope of the Project: To provide shelter services to prevent the removal of children from their families; to provide behavioral health services to children; and to provide professional development and training opportunities to HSA staff and foster parents.
