**SUBJECT:** Recommendation to accept a Federal Title IV-B Subpart 2 grant award from the State of Nevada, Division of Child and Family Services in the amount of [\$55,290; \$18,430 county match] for Family Reunification services, retroactive to July 1, 2021 through June 30, 2022; authorize the Director of the Human Services Agency to execute the sub-grant award; and direct the Comptroller's Office to make the necessary budget amendments. ### **SUMMARY**

The overall goals of Federal Title IV-B Subpart 2, Promoting Safe and Stable Families (PSSF) program are to prevent the unnecessary separation of children from their families, improve the quality of care and services to children and their families, and ensure permanency for children by reuniting them with their parents, by adoption or by another permanent living arrangement.

Funds under PSSF are separated into four service categories. We recommend to accept a Federal Title IV-B Subpart 2 grant award in the service category of Family Reunification in the amount of [\$55,290; \$18,430 county match]. Funds are awarded from the State of Nevada Division of Child and Family Services retroactively from July 1, 2021 through June 30, 2022. Funds will support the safe and successful reunification of children with their parents, or another permanent living arrangement.

**Washoe County Strategic Objective supported by this item:** Safe, secure and healthy communities.

### **PREVIOUS ACTION**

On August 31, 2020, the Board of County Commissioners approved item #5.G.4, the Department's request to accept a Federal Title IV-B Subpart 2 grant award from the State of Nevada Division of Child and Family Services in the amount of [\$31,397; \$10,466 county match] for Family Reunification services, retroactive to July 1, 2020 through June 30, 2021.

On September 24, 2019, the Board of County Commissioners approved item #18, the Department's request to accept a Federal Title IV-B Subpart 2 grant award from the State of Nevada, Division of Child and Family Services in the amount of [\$14,664; county match \$4,881.34] for Family Support, [\$39,938; county match \$13,312.66] for Family Preservation, [\$55,025; county match \$18,341.67] for Family Reunification, and [\$167,603; county match \$55,867.66] for Adoption Promotion and Support, retroactive to July 1, 2019 through June 30, 2020.

On September 12, 2018, the Board of County of Commissioners approved item #6.K.5, the Department's request to accept \$58,000 (\$19,333 match) in Federal Title IV-B Subpart 2 funds from the State of Nevada Division of Child and Family Services retroactive to July 1, 2018 through June 30, 2019.

### **BACKGROUND**

The purpose of the Promoting Safe and Stable Families (PSSF) program is as follows:

- Promote flexibility in the development and expansion of a coordinated child and family services program that utilizes community-based agencies and ensures all children are raised in safe, loving families, by protecting and promoting the welfare of all children;
- Prevent the neglect, abuse, or exploitation of children;
- Support at-risk families through services which allow children, where appropriate, to remain safely with their families or return to their families in a timely manner;
- Promote the safety, permanence, and well-being of children in foster care and adoptive families; and
- Provide training, professional development and support to ensure a well-qualified child welfare workforce.

In accordance with this purpose, this award under the Family Reunification category will support the reunification of families with services including, but not limited to: prepaid cell phones, childcare and respite care, housing/utility assistance, nutrition, transportation and safety related items.

Retroactive approval is requested as the notice of subaward (NOSA) was received August 6, 2021 with a grant period start date of July 1, 2021.
