PREVIOUS ACTION

On November 10, 2015, the Board of County Commissioners accepted a presentation by Aaron Kenneston, Washoe County Emergency Manager, and an EMAP Commissioner, on the Emergency Management Accreditation Program (EMAP); and accepted a Plaque in recognition of EMAP Accreditation.

BACKGROUND

The Emergency Management Accreditation Program (EMAP), is an independent non-profit organization that fosters excellence and accountability in Emergency Management and Homeland Security Programs. It establishes credible standards applied in a peer review accreditation process. This process helps programs create safer communities through measurable standards of excellence for Emergency Management programs. The Emergency Management Standard by EMAP is a set of 66 standards by which programs that apply for EMAP accreditation are evaluated. The Emergency Management Standard is designed as a tool for continuous improvement as part of the voluntary accreditation process for local, state, federal, higher education and tribal Emergency Management programs.
