

- Completed September 2022
- Opportunity to build health equity organizational capacity
- Implemented BARHII health equity assessment
- Resulted in a three-year equity plan





Health Equity Plan (HEP)

- Program Misson: Improve health outcomes by addressing health disparities among diverse populations in Washoe County
- HEP 7 overarching goals:
 - Build health-equity competency among staff
 - Build capacity to integrate health equity in programs
 - Build partnerships with diverse communities to improve public health
 - Community access to culturally and linguistically appropriate public health information
 - Collect, evaluate, and leverage health equity data to inform program and policy development, and decision-making efforts
 - Integrate health equity efforts into organizational development efforts
 - Refine and improve hiring practices to recruit and retain a diverse workforce that represents the community we serve



FY24 Status of HEP Initiatives




Annual Report Results




