14 **PETITION FOR PARTIAL DISTRIBUTION AND APPROVAL OF FEES AND**  
15 **ADMINISTRATIVE EXPENSES**

16 On June 4, 2025, REW R. GOODENOW, Executor, by and through his attorney, J.  
17 DOUGLAS CLARK, ESQ., filed a *Petition to Amend Order* in which they requested  
18 to correct the distribution amounts in the *Order Approving Third Account and*  
19 *Report and Petition for Partial Distribution and Approval of Fees and Administrative*  
20 *Expenses*. The request is Granted, and the amended order appears in full below:

21 On March 31, 2025, REW R. GOODENOW, Executor, by and through his attorney,  
22 J. DOUGLAS CLARK, ESQ., filed a *Third Account and Report and Petition for Partial*  
23

1 *Distribution and Approval of Fees and Administrative Expenses.* Upon review of the  
2 pleadings on file herein, and GOOD CAUSE APPEARING therefor,

3 1. That the Third Report to the Court of the Executor is APPROVED; and

4 2. That the sum Two Hundred Eighty-Eight Thousand Eight Hundred  
5 Thirty-Eight Dollars and Forty-Eight Cents (\$288,838.48) for Executor's fees is  
6 confirmed and approved and that the sum of Two Hundred Sixteen Thousand Six  
7 Hundred Twenty-Eight Dollars and Eighty-Six Cents (\$216,628.86) be paid as a  
8 partial payment of statutory Executor fees, leaving the sum of Seventy-Two  
9 Thousand Two Hundred Nine Dollars and Sixty-Two Cents (\$72,209.62) to be paid  
10 as a partial payment of statutory Executor's fees in the final accounting and the  
11 Executor is ordered to pay the same.

12 3. That the sum of One Hundred Thirty-Five Thousand Four Hundred  
13 Seventeen Dollars and Twelve Cents (\$135,417.12) is confirmed and approved as  
14 the amount due for reasonable compensation for ordinary statutory legal services  
15 rendered by J. Douglas Clark, Attorney at Law, Ltd. and that the sum of One  
16 Hundred One Thousand Five Hundred Sixty-Two Dollars and Eighty-Four Cents  
17 (\$101,562.84) be paid as a partial payment of attorney's fees, leaving the sum of  
18 Thirty-Three Thousand Eight Hundred Fifty-Four Dollars and Twenty-Eight Cents  
19 (\$33,854.28) to be paid as payment of statutory attorney's fees in the final  
20 accounting and the Executor is ordered to pay the same.

21 4. That the sum of Six Thousand Nine Hundred Sixty-Seven Dollars and  
22 Fifty Cents (\$6,967.50) is confirmed and approved as the amount due for attorney  
23 extraordinary fees and the Executor is ordered to pay the same.

1           5.     That the sum of Two Thousand Four Hundred Eighty-Three Dollars  
2 and Fifty-Six Cents (\$2,483.56) be confirmed and approved as the amount for  
3 reimbursement for costs advanced by J. Douglas Clark, Attorney at Law, Ltd., and  
4 that the Executor is ordered to pay the same.

5           6.     That after the payment has been made of the aforementioned  
6 obligations arising from the administration of the estate, the Executor is order to  
7 pay the full collective distribution in the sum of One Million Three Hundred  
8 Seventy-Seven Thousand Six Hundred Ninety-Five Dollars (\$1,377,695) to the
