PREVIOUS ACTION

On August 22, 2024.00, the District Board of Health approved this subaward in the total amount of \$1,216,230.00 for the period of January 1, 2024 through July 31, 2026.

BACKGROUND

This Award supported the Epidemiology and Public Health Preparedness (EPHP) Division's Epidemiology Program by completing epidemiological surveillance and investigation activities and incorporating data into already existing reports. The funding from this award supported personnel, contracted personnel, training, subscriptions, and telephone expenses.

On March 24, 2025, the State of Nevada issued a notice terminating this award, stating that all associated activities must cease.
