## SUMMARY

The Washoe Board of County Commissioners must approve amendments to the adopted fiscal year budget and direct Finance to make the appropriate budget amendments.

## PREVIOUS ACTION

On October 23, 2025, the District Health Officer executed this subaward amendment in the total amount of \$376,124 for the period of June 1, 2025 through May 31, 2026.

## BACKGROUND

The HIV Prevention Program collects, analyzes, interprets, and disseminates human immunodeficiency virus (HIV) data to characterize trends in HIV infection, detect active HIV transmission, implement public health interventions, and evaluate public health response.

The Subaward provides funding for personnel, travel, training, operating, medical supplies, marketing, testing and laboratory services, and indirect expenditures.

## GRANT AWARD SUMMARY

**Project/Program Name:** Population Heath Division, HIV Prevention Program

**Scope of the Project:** The purpose of this subgrant is to support HIV prevention services in Washoe County.

**Benefit to Washoe County Residents:** Funds will be used to support costs associated with HIV prevention in Washoe County.

**On-Going Program Support:** NNPH will seek ongoing support through the Federal or State funding programs.

**Award Amount:** \$376,124.00 (\$341,928.00 direct/\$34,196.00 indirect)

**Grant Period:** June 1, 2025 through May 31, 2026
