SUMMARY

The Manager's Office recommends that the Board of County Commissioners appoint and/or reappoint members of the Commission to the following boards and commissions with terms expiring soon:

- Truckee Meadows Regional Planning Agency Governing Board Clark (term expires 1/25)
- Washoe County Criminal Justice Advisory Committee Clark (term expires
- Washoe County Internal Audit Committee Hill (term expires 1/25), Herman (term expires 1/25)
- Washoe County School District Oversight Panel Andriola (term expires 1/25)
- Western Regional Water Commission Andriola (term expires 3/25)

The Commission also retains the discretion, where legally permissible, to alter or reassign memberships or terms of service for other boards whose memberships are not expiring within the coming year.

PREVIOUS ACTION

On January 16, 2024, the Board of County Commissioners approved appointments and/or reappointments to the "various" boards and commissions.

On April 18, 2023, the Board of County Commissioners approved appointments and/or reappointments to the "various" boards and commissions within the same calendar year due to the resignation of District 4 Commissioner Vaughn Hartung and appointment of Commissioner Clara Andriola to the District 4 commission seat

On January 3, 2023, the Board of County Commissioners approved appointments and/or reappointments to the "various" boards and commissions.

On October 22, 2022, the Board of County Commissioners approved appointments and/or reappointments to the "various" boards and commissions within the same calendar year as some members of the Commission were absent at the Strategic Planning Workshop on October 4, 2022.

On October 4, 2022, the Board of County Commissioners approved appointments and/or reappointments to the "various" boards and commissions, and accepted Truckee North Tahoe/Transportation Management Association (TNT/TMA) as a new board, based on changes to TNT/TMA's bylaws.

On January 11, 2022, the Board of County Commissioners approved appointments and/or reappointments to the "various" boards and commissions.

On January 12, 2021, the Board of County Commissioners approved appointments and/or reappointments to the "various" boards and commissions.

On January 14, 2020, the Board of County Commissioners approved appointments and/or reappointments to the "various" boards and commissions.

BACKGROUND

Prior to terms expiring and/or the end of the calendar year, the Board of County Commissioners discusses and potentially takes action regarding the appointment or reappointment to various internal and external boards and commissions where their representation is required.

In addition to serving on the county commission, the Nevada County Commissioner Handbook notes that commissioners may be appointed to represent their county on other boards and committees as part of their official duties. These appointments can be made annually by the chairman of your board or by other governmental entities.

FISCAL IMPACT

There is no fiscal impact to Washoe County for appointments/reappointments to "various" boards and commissions.
