### **SUMMARY**

The Community and Clinical Health Services Division received the attached Notice of Subaward from the State of Nevada Department of Health and Human Services on September 9, 2024, to support the Family Planning Program retroactive to July 1, 2025 through June 30, 2025. #### **BACKGROUND**

The Community and Clinical Health Services Family Planning Program has been awarded funding for Fiscal Year 2026 to support the integration of vaccine delivery into comprehensive, client-centered, and high-quality family planning services. This funding will enhance the program's ability to provide holistic reproductive health care by offering immunizations as part of routine family planning visits. The initiative is designed to improve access to preventive services and promote positive health outcomes, particularly among underserved and vulnerable populations throughout Washoe County. By aligning immunization efforts with reproductive health care, the program aims to reduce health disparities and strengthen community well-being.
