




→ Lake Elevation

4th property – Escrow to close March 1st


Property clearing/clean up – Summer 2022

#### **Temporary Barrier Removal**

- Temporary HESCO and Tiger Dam barriers
- Pumps, piping and roadway crossings
- Removal of all culvert plugs under residential roadways
- Restoration of Lemmon Drive
- Restoration of residential driveways Lemmon Drive, Pompe Way
- Regrade roadside ditches
- Final debris removal
- Earthen berm end of Pompe Way
- Arkansas Road September 2019
- Lemmon Valley Elementary School July/August 2021
- Lemmon Drive culvert plugs January 2022






#### FEMA 100-Year Flood Plain

- > 2017 flooding revealed inaccurate FEMA 100-year flood risk maps (FIRM)
- Initiated study to update regulatory 100-year (1%) flood plain limits and depth
  - Statistical and hydrological analysis includes historic, measured data sets and risk assessment
  - 500-year non-regulatory flood plain
- DRI Study completed January 2022
  - Conform data sets
- Update flood plain current and future mitigation projects
- Commitment to potential impacted residents/businesses







### **Long-Term Mitigation**

Reduce flood risk to existing and future residents/businesses, protect critical infrastructure

Updated Policies – volumetric mitigation, retention/detention basins

≻"Matrix"

- 5 alternatives, reduced from 25+ concepts
- Phase I engineering studies and risk assessments

Swan Lake Operation Plan

During high precipitation/flood

Divert water away from lake, protect residents/businesses/infrastructure

During drought/no precipitation

Divert water to lake, preserve wildlife habitat and enhance quality of life




