### SUMMARY

A vacancy opened on the Washoe County Senior Advisory Board (District 1) as of October 31, 2024 as a result of the expiration of Marvis Kay Bosner's term. At the November 6, 2024, the Senior Advisory Board recommended to appoint Patricia Gallimore from the Alternate position she currently holds into the vacant District 1 position. It is requested that the Board of County Commissioners approve this appointment, which would be effective immediately and expire on November 30, 2028.

### PREVIOUS ACTION

On November 6, 2024, the Washoe County Senior Advisory Board recommended to appoint Patricia Gallimore from the Alternate position she currently holds into a position representing District 1.

### BACKGROUND

Washoe County Code 45.415 authorizes the Senior Advisory Board to include 11 members of the community, two members from each commission district, one at large member who shall serve as a permanent member and two at large alternates who shall serve in the absence of a permanent member. The members are appointed by the Board of County Commissioners to serve a four-year term and may serve, with reappointment, a maximum of two consecutive terms. The Senior Advisory Board members must be, as required by County Code, residents of the County and have an interest in civic affairs, and an interest or experience in the fields of nutrition, geriatric social work, administration, finance, and law.
