# Environmental Health Program Activities:

**Consumer Protection Programs** 

Food Safety Plan Review & Operations

Special Processes & Program Standards Team

- Members of the Special Processes & Program Standards Team hosted the Active Managerial Control (AMC) Program course for 14 food establishments. There is only one more AMC Program course scheduled for the calendar year on December 18<sup>th</sup>.
- In partnership with the EPHP division, the Special Processes & Program Standards Team restarted the process of updating the Foodborne Illness Outbreak Response Plan. Efforts to finalize this plan will continue into 2025.

#### Food Safety Plan Review

- Staff have been working with Anna's Taqueria at their new location. The applicant remodeled the old Nik n Willies location down South without building permits, and they are currently in the process of getting everything permitted. This location also has a commercial septic system and will need to be working with NDEP to ensure proper waste disposal.
- Staff has been finalizing various projects for the food plan's subprogram in which one project will be a construction guide packet to help stakeholders in the requirements in building a food facility.

#### Temp Foods / Special Events / Mobile Foods

- In November, the team worked the Riverside Farmers' Market Holiday Bazaar which attracts roughly 5,000 people and has over 100 food, craft, and artisan vendors. Team also conducted inspections at Fantasies in Chocolate at the GSR, and Barrels and Bites at the Peppermill.
- Staff worked with the City of Reno on process improvements to both streamline the mobile foods servicing area agreements and increase interagency coordination to ensure accurate information between agencies regarding mobile foods.

Commercial Plans / Development Reviews

- Commercial Plans are continuing to trend lower in submittals over the previous year and time period.
  - At this time, EHS has received 9% less plans than 2023. Ultimately, EHS is expecting to be close to the total number of plans reviewed in 2023.
- EHS received 97 Commercial Plans to review and conducted 167 different reviews during the month.
- 86% of all plans in October were reviewed within the regional goal of 14 days.
  - 21 plans of the 155 that were submitted in October did not meet the regional goal for review.

## **Environmental Protection**

Residential Septic & Well Plan Reviews

- Septic and well plan intake has exceeded the prior year, though still down from a peak in 2022. Inspections fell in November, as to be expected as the weather begins to change.
- Staff provided one realtor presentation in the community. This was the first time the presentation was live streamed, with dozens of views. It will remain available for people to see and may have set the tone for future presentations.

#### Safe Drinking Water

- Four sanitary surveys were completed in the month of November. Two remain for the year.
- The team was advised by a water system that certain lead and copper samples had been improperly taken and reported. The systems operator had taken multiple samples from a single site and then reported that they were taken as required by their plan. The team is working with Bureau of Safe Drinking Water to deal with the samples and the operator.

#### Vector-Borne Disease Program

- Staff are in the process of repairing/winterizing all adult mosquito surveillance traps in preparation for the 2025 mosquito season.
- Staff are reviewing the 2024 mosquito treatment/surveillance data in preparation for the annual report for the NDEP National Pollution Discharge Elimination System (NPDES).

Waste Management / Underground Storage Tanks (USTs)

- UST staff inspected 12 fuel sites in the month of November.
- UST staff reviewed and approved a site assessment report for a system that was closed last month.
- UST Staff witnessed the installation of tanks for a new system in North Reno as well.
- Waste Management Staff began the process of updating the 2025 permit list for staff to be ready for the new year.
- Initial conversations began with Keep Truckee Meadows Beautiful for contract negotiations in 2025. Over the years, much of the contract scope of work has changed or needs modification. The contract ends July 1, so it is expected to be brought to DBOH by May.
