Summary for February 2024

In February, TMFR Firefighters responded to three structure fires, all with no injuries reported or loss of life.

A few winter storms created treacherous driving conditions, particularly in the higher elevations and in Washoe Valley. Crews responded to an increase in motor vehicle accidents.

It was a good month for our fuels reduction crews to participate in a number of prescribed burning operations with regional partners to include a 250 pile burning operation south of Galena Creek Regional Park. Crews were on site 24-hours for multiple days to ensure the piles were fully extinguished.

February's cold temperatures allowed TMFR Training to perform ice rescue operations for all firefighting personnel at Galena Creek Park. And a reduction of wildfire activity due to ground moisture allowed the Fire District to offer additional training exercise such as auto extrication.


Daytime and nighttime prescribed burning operations near Galena Creek Regional Park in early February.








