## **SUMMARY**

The Washoe County Sheriff's Office Citizen Corps Program has received a donation in the amount of \$1,500.00 for their volunteer efforts at the Reno Air Races event (formerly the National Championship Air Races), a community event held October 4-6, 2024. This donation will go to support the Citizen Corps Programs (CCP), whose volunteer teams include the Community Emergency Response Team (CERT), Citizen's Homeland Security Council (CHSC) / Terrorism Liaison Officer Volunteer (TLOV) program and Rail Auxiliary Team (RAT).

These funds are intended to be used to support the CCP teams, including but not limited to the purchase or repair of equipment, supplies, food and beverage to be used in emergency response, training, drills, support events or rehab during disasters, in support the Citizen Corps Programs.

**Washoe County Strategic Objective supported by this item**: Innovative Services – Strengthen our culture of service.

## **PREVIOUS ACTION**

The Board has been approving donations from the Reno Air Racing Association to the Washoe County Citizen Corps Program (CCP) since 2013.

## **BACKGROUND**

The Washoe County Sheriff's Office has a robust Citizen Corps Volunteer Program (CCP) that is supported primarily by grants and donations. These funds will be used to support the CCP programs.

## FISCAL IMPACT
