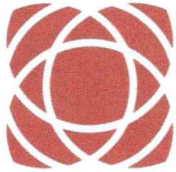

In follow up to our conversation earlier this week, due to a number of changes being made to ensure the financial viability of the project, Sutro Senior Sanctuary, we are providing official notice of our decision to decline the \$1m award.

The specific reason for declining the award is substantive changes to the unit mix which essentially disqualify the project for the award which was originally applied for. We know that Sutro and all projects are important to Washoe and are hopeful this award will be used as intended by another project in the near term.

We are extremely appreciative of the support we received from the team at the Washoe County Affordable Housing Trust and are excited to continue to move forward with the intention of formally closing the project in the upcoming months.
