When submitting this Change Order, submit/attach changes including all supporting documentation as required by the System Purchase Agreement between Washoe County and Harris Corporation Communication Systems Segment, dated September 27, 2018, to this form.

Change Summary:

This Change Order No. 20 to the Agreement (this "Change Order") is effective as of January 6, 2026 (the "Change Order Effective Date"), by and between Washoe County ("Washoe") and L3Harris Technologies, Inc., formerly known as Harris Corporation, ("L3Harris"), and supplements that certain System Purchase Agreement, dated 09/27/2018 as amended by Change Orders 1 through 19 (the "Agreement").

Capitalized terms used but not defined herein shall have the meaning assigned thereto in the Agreement.

For and in consideration of the mutual covenants and conditions contained herein, and for other good and valuable consideration, receipt of which each party hereby acknowledges, Washoe and L3Harris agree to modify the Agreement as follows:

1. The scope of work and price to complete Site Development for the Project Site "Red Peak," as modified as of June 6, 2025 by Change Order #19, shall be amended as set forth in the Pricing and Scope Summary, attached to this Change Order and made a part hereof as Schedule 1.
2. L3Harris shall invoice, and Washoe County shall pay, for the Red Peak Site Development, as set forth in the Revised Milestone Payment Schedule, attached to this Change Order and made a part hereof as Schedule 2.
3. L3Harris and Washoe County shall schedule a kickoff meeting, to occur within 10 business days of the Change Order Effective Date, for the purpose of, among other things, scheduling the work contemplated by this Change Order by mutual agreement (the "Red Peak Implementation Schedule"). Any dates in the Integrated Master Schedule pertaining to the Red Peak site are void and will be replaced with the Red Peak Implementation Schedule.

This Change Order, together with all attachments hereto, is hereby incorporated into and made part of the Agreement as if fully set forth therein. The terms and conditions of the Agreement, except as amended herein, shall remain in full force and effect. The parties have caused this Change Order to be executed as of the Change Order Effective Date.



SCHEDULE 1

Pricing and Scope Summary

General Scope and Price Changes. Site civils construction to be performed by L3Harris's subcontractor, Nevada Tower, LLC, as set forth in the Agreement as modified by Change Order #7, Change Order #12 and Change Order #19. The pricing in this Change Order #20 (for Site Development, i.e., site civils construction) excludes, and is in addition to, the pricing in Change Order #19 (for electrical changes to materials and equipment supporting Site Development).

Tariff Adjustment. Buyer acknowledges that the cost of materials supplied under this Change Order may be subject to tariffs imposed by governmental authorities. The exact amount of such tariffs is uncertain at the time of the Change Order Effective Date due to potential changes expected in the Harmonized Tariff Schedule (HTS), located at <https://hts.usitc.gov/>. In the event of a change in the amount of tariffs on the materials supplied under this Agreement, Seller shall have the right to revise its estimate and adjust the price to be charged to Buyer to reflect the actual cost of the tariff paid by Seller's supplier, plus a markup of twenty-five percent (25%) on such material cost incurred due to the tariff.

Reconciliation Process:

- a. Invoice from Supplier: The Seller shall obtain an invoice from its supplier that details the tariff cost based on the HTS in force at the time the materials were acquired.
- b. Notification to Buyer: The Seller shall promptly notify the Buyer in writing of the actual tariff cost incurred and provide a copy of the supplier's invoice as evidence of the tariff amount and, if the parties desire, modify the contract sum accordingly.
- c. Payment Adjustment: The Buyer agrees to pay the Seller the tariff cost as evidenced by the supplier's invoice (or such contract modification relating to it), plus a twenty-five percent (25%) markup on such tariff cost. This adjustment shall be reflected in Seller's invoice submitted under this Change Order.

Market Prices for Site Development. The firm-fixed price values of Site Development were adjusted from their values in Change Order #12 to reflect current market pricing as of the Change Order Effective Date. The price of Change Order #20 shall be as follows:
