SUMMARY

The Sheriff's Office is seeking approval for a one-time cash donation from a private citizen for \$300.00 to be used for operating costs.

BACKGROUND

The Washoe County Sheriff's Office was sent a check in the mail in the amount of \$300.00 from private citizen, Elsie Kelly who met some of the team members at an event in early 2024.

Recently, Washoe County Sheriff's Office started back up the Mounted Horse Unit. These Deputies on horseback are a unique benefit to the Sheriff's Office and the public. They will be utilized at major community events such as the Reno Rodeo, Hot August Nights, and Red, White and Tahoe Blue in addition to local parks and open space patrols. These funds are intended to be used to support the Washoe County Sheriff's Office Mounted Horse Unit.
