#### **SUMMARY**

Recommendation to accept a FY24 Continuum of Care Supportive Services Only Coordinated Entry for Survivors of Domestic Violence grant award from the United States Department of Housing and Urban Development in the amount of [\$31,500.00; \$7,875.00 county match] for the period January 1, 2026 through December 31, 2026 to support the Continuum of Care initiative with planning, coordinated entry matchmaker activities and implementation of specific policies and procedures to address domestic violence survivors' needs in accessing services; retroactively authorize the Director of the Human Services Agency to execute grant award documents; and direct Finance to make the necessary budget amendments.

Washoe County Strategic Objective supported by this item: Vulnerable Populations

#### PREVIOUS ACTION

On December 17, 2024, the Board approved item 7.D.2 the Department's request to accept the FY23 Supportive Services Only Coordinated Entry Domestic Violence Expansion grant from the United States Department of Housing and Urban Development to support the Continuum of Care initiative with coordinated entry matchmaker activities; in the amount of [\$30,000.00, \$7,500.00 county match] for the retroactive period January 1, 2025 through December 31, 2025.

On November 28, 2023, the Board of County Commissioners approved item 7.D.1 the Department's request to accept three grant awards from the United States Department of Housing and Urban Development to support the Continuum of Care initiative with planning, coordinated entry matchmaker activities and implementation of specific policies and procedures to address domestic violence survivors' needs in accessing services; (1) in the amount of [\$72,185.00, \$20,948.20 county match] retroactive for the period July 1, 2023 through June 30, 2024; (2) in the amount of [\$30,000.00, \$10,789.00 county match] retroactive for the period May 1, 2023 through April 30, 2024; and (3) in the amount of [\$30,000.00, \$10,788.96 county match] for the period January 1, 2024 through December 31, 2024.

On October 25, 2022, the Board of County Commissioners approved item 8.D.1 to accept a 2021 Continuum of Care Planning Grant from the United States Department of Housing and Urban Development in the amount of \$68,176.00; \$17,044.00 county match, retroactive from of July 1, 2022 through June 30, 2023.

On August 30, 2021, in a joint concurrent meeting between the City of Reno, the City of Sparks, and Washoe County, the Board of County Commissioners approved Amendment No. 2 as an extension of the Interlocal Cooperative Agreement for Shelter Operation and other Homeless Services among the City of Reno, City of Sparks, and Washoe County; this amendment transferred the administrative and financial responsibility for the operation of the homeless shelters in Washoe County, Nevada to Washoe County.

On January 13, 2021, direction was provided by the BCC to include pursuing an expanded role in addressing the regional issue of homelessness in the Strategic Plan.

#### **BACKGROUND**

Washoe County serves in the lead entity role for the region's Continuum of Care, a United States Department of Housing and Urban Development program designed to promote communitywide commitment to the goal of ending homelessness. Grant funds provide for periodic planning activities needed in the renewal and ongoing operations of the Continuum of Care Program, the expansion and specialization of the Coordinated Entry system to increase efficiency and to ensure that domestic violence survivors' needs in accessing services are addressed. This funding will support Washoe County in its effort to supportive services for the Northern Nevada Continuum of Care.

**Project/Program Name:** Continuum of Care Program

**Scope of the Project:** Funding to assist with supportive services related to the Continuum of Care program. This grant agreement includes new language requiring the grantee to follow all current Presidential Executive Orders.

**Benefit to Washoe County Residents:** This project provides funding for supportive services in support of the program's efforts to promote community-wide commitment to the goal of ending homelessness.
