

Amendment No. 1 to
Interlocal Agreement No. NM467-16-015

This Amendment is made and entered into on _____, between the State of Nevada, acting by and through its Department of Transportation, hereinafter referred to as the "DEPARTMENT", and Washoe County, hereinafter referred to as the "COUNTY."

WITNESSETH:

WHEREAS, on September 8, 2016, the parties entered into Interlocal Agreement: Maintenance and Operations of the Nevada SR-28 Shared Use Path and Associated Parking Facilities, No. NM467-16-015, hereinafter referred to as the "AGREEMENT," to define the respective operations and maintenance responsibilities for the IMPROVEMENTS incorporated into the PROJECT (capitalized terms not defined here are defined in the AGREEMENT), including the shared-use path now known as the Tahoe East Shore Trail and the associated parking facilities now known as the North Trailhead Parking – Ponderosa Ranch; and

WHEREAS, the Parties desire to amend the AGREEMENT to incorporate certain improvements under Project TAP-0028-(340), EA 74467 (STIP Project ID: WA20220008; Agreement No. PR 462-22-063), which proposes the construction of approximately thirty-eight (38) public parking spaces, three (3) employee parking spaces, a connecting shared-use path, and the formalization of an existing transit stop, and Project STBG-0028-(341), EA 74468 (STIP Project ID: XS20170020; Agreement No. PR 463-22-063), which proposes the relocation of on-highway parking, parking lot extensions, approximately 0.9 miles of trail, a prefabricated bridge, a pedestrian signalized crossing, and pullouts between Chimney Beach and Secret Harbor for parking, transit, trail, and safety improvements, including the installation of a pedestrian crossing at the Chimney Beach parking lot, into the PROJECT, which shall collectively be referred to as the "ADDITIONAL PROJECTS"; and

WHEREAS, this Agreement shall be converted to a payable agreement, and the Agreement Number shall be updated to P467-16-015; and

WHEREAS, the Parties desire to amend the AGREEMENT to extend the routine maintenance and capital infrastructure maintenance responsibilities previously established in the AGREEMENT to the ADDITIONAL PROJECTS.

NOW, THEREFORE, the parties hereby agree to amend the Agreement as follows:

1. The parties agree that the ADDITIONAL PROJECTS shall be incorporated into and deemed part of the PROJECT, as if they were originally included in the Agreement.

2. The parties agree that the ADDITIONAL PROJECTS shall be subject to all applicable, terms, conditions, responsibilities, and obligations set forth in the AGREEMENT, including those set forth in the State Route 28 (SR-28) Corridor Operations and Maintenance Interlocal Agreement, dated August 1, 2015.

3. Article 1 – County Agrees, Paragraph 8, is amended by deleting it in its entirety and inserting in its place:

"To invoice the DEPARTMENT for one hundred percent (100%) of the replacement or repair costs associated with lighting and two (2) RRFB signs located at Lakeshore Boulevard and SR-28, as well as two (2) RRFB signs located at SR-28 within the Chimney Beach parking lot, for equipment repaired or replaced due to accidental damage, provided that such costs exceed One Thousand and No/100

Dollars (\$1,000.00) and are unrecoverable through insurance or other sources. In the event the anticipated repair or replacement costs exceed One Thousand and No/100 Dollars (\$1,000.00), the COUNTY shall notify the DEPARTMENT prior to initiating repairs in order to coordinate the required repair or replacement.”

4. Article I - County Agrees, is amended and supplemented by adding the following paragraphs:

- a. “To operate and maintain the two (2) RRFB signs and all associated pedestrian crossing infrastructure, including advance warning signage, crosswalk pavement markings, other pavement markings, and lane line striping required for the pedestrian crossing system located at the Chimney Beach parking lot along SR-28, in Washoe County, Nevada. Repainting of crosswalk pavement markings and other pavement markings shall occur at least once annually, preferably during the spring of each year.”
- b. “To be responsible for furnishing and installing all pavement striping for the pedestrian crosswalk located at the Chimney Beach parking lot, as depicted in **Attachment A.1**, as well as the pavement striping associated with the transit pullout located on the west side of SR-28, north of the pedestrian crossing near Lakeshore Boulevard, as depicted in **Attachment B.1**.”

5. Article II – Department Agrees, Paragraph 1 is amended by deleting it in its entirety and inserting in its place:

“To participate with the COUNTY in the costs of replacement necessary for major repairs resulting from accidental damage to the pedestrian crossing systems located at Lakeshore Boulevard and SR-28 and at SR-28 within the Chimney Beach parking lot, including associated lighting and two (2) RRFB signs, provided that such repair/replacement costs exceed One Thousand and No/100 Dollars (\$1,000.00) and are unrecoverable from third-party insurance or other sources. The DEPARTMENT’s participation shall be one hundred percent (100%) of the cost of infrastructure repaired or replaced in excess of One Thousand and No/100 Dollars (\$1,000.00). In the event such costs exceed One Thousand and No/100 Dollars (\$1,000.00), the COUNTY shall notify the DEPARTMENT to coordinate the required repairs or replacement.”

6. Article II – Department Agrees, is amended and supplemented by adding the following paragraph:

“To be responsible for the maintenance of the pavement for the transit pullout located on the west side of SR-28, north of the existing pedestrian crossing near Lakeshore Boulevard, as depicted in **Attachment B.1**.”

7. All of the other provisions of the AGREEMENT shall remain in full force and effect as if fully set forth herein.

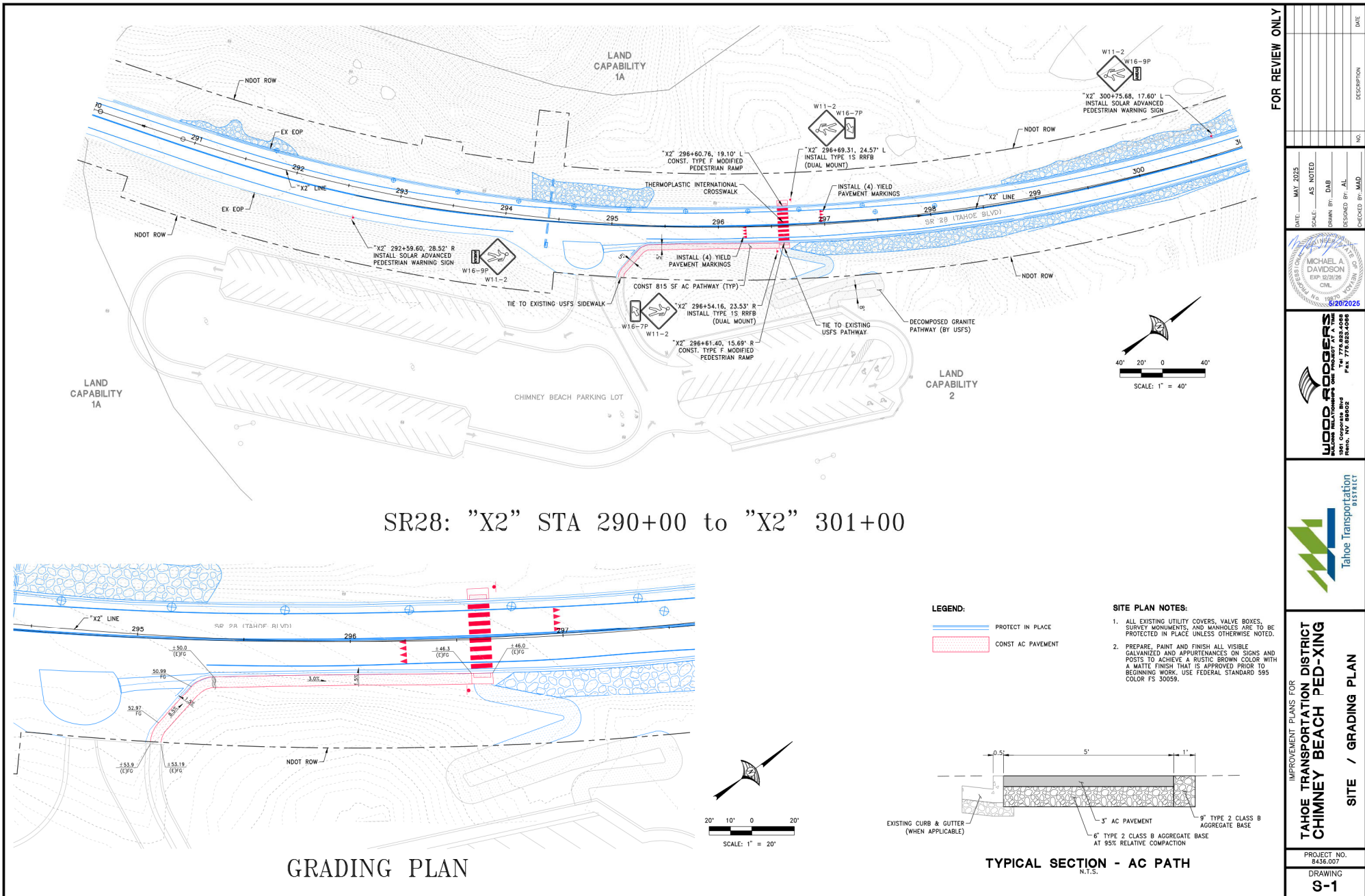
