PREVIOUS ACTION

On May 25, 2021, The Washoe County Board of County Commissioners accepted a donation of 44 Narcan Kits to treat and prevent possible opioid overdoses by community members served by the Washoe County Department of Juvenile Services [estimated value \$3,300] donated by Quest Counseling and Consulting Inc.

BACKGROUND

Quest Counseling and Consulting Inc. has made a donation to Juvenile Services of 50 Narcan Kits, valued at approximately \$75 each, to treat and prevent possible opioid overdoses for community members served by Juvenile Services.

Narcan is a valuable tool available to first responders to provide emergency treatment of possible opioid overdoses. With this donation, Juvenile Services Probation Officers will now have quick access to Narcan in the field, should they have an interaction with a person or persons in distress from a possible drug overdose in our community.
