SUBJECT: Recommendation to accept grant funding [\$19,881.75 with no County match] for Fiscal Year 2026 from the United States Department of Agriculture Forest Service, received under the Secure Rural Reauthorization Act of 2025 (SRS Act) for the benefit of public schools and roads within Washoe County and direct Finance to make the necessary budget amendments. (All Commission Districts.) FOR POSSIBLE ACTION

SUMMARY

Washoe County receives an annual allocation of funds through the SRS Act. The \$19,881.75 received is 50% of the distribution from the US Forest Service under the SRS Act of 2025 and is allocated to Washoe County to be used for roads within the County. The other 50% is directed to the Washoe County School District.

Washoe County Strategic Objective supported by this item: Fiscal Sustainability. Long Term Sustainability.

PREVIOUS ACTION

On April 28, 2026, the Board of County Commissioners (Board) accepted \$15,628.09 from the USDA Forest Service under the SRS Act, which was reauthorized by Congress in December 2025 to continue through FY28.

On June 25, 2024, the Board of County Commissioners (Board) accepted \$18,161.48 from the USDA Forest Service under the SRS Act, which was reauthorized by Congress in December of 2021.

On June 27, 2023, the Board of County Commissioners (Board) accepted \$21,226.82 from the USDA Forest Service under the SRS Act, which was reauthorized by Congress in December of 2021.

On June 28, 2022, the Board accepted \$22,514.97 from the USDA Forest Service under the SRS Act, which was reauthorized by Congress in December of 2020.

On May 18, 2021, the Board accepted \$17,277.34 from the USDA Forest Service under the SRS Act, which was reauthorized by Congress in December of 2019.

The Board has accepted funds annually when they have been received.

BACKGROUND

Funding is provided to States and Counties from the U.S. Forest Service under 16 U.S.C. 500. The program objective is to share receipts from the National Forests with the states in which the forests are located. Funds are distributed equally between the Washoe County School District and Washoe County. Washoe County’s share of funds is to be used for the benefit of public roads within the County.

Scope of the Project: Funding is provided to States and Counties from the U.S. Forest Service under 16 U.S.C. 7101. The program objective is to share receipts from the National Forests with the states in which the forests are situated. Washoe County’s share of funds is to be used for the benefit of public roads within the County.

Benefit to Washoe County Residents: This funding supplements the budget for roads maintenance and projects, which are currently funded primarily through fuel taxes.
