Dear Ms. Campbell:

In response to your August 21, 2025 grant application, the Directors of The Nell J. Redfield Foundation ("Redfield") have approved a grant totaling \$20,000.00 + \$5,000.00 in matching funds to Washoe County Sheriff's Office ("Recipient"), subject to our receipt of this signed Grant Agreement Letter.

CONDITIONS

1. The grant is to be used solely to support the Hope Clean Path Initiative Program as detailed in your August 21, 2025 application.
2. Grant Recipient warrants and represents that its receipt of this grant will not adversely affect its status as a public charity under Section 509(a) of the Internal Revenue Code.
3. Grant Recipient will furnish Redfield any information concerning a change or proposed change in your tax exempt status.
4. If Grant Recipient's tax-exempt status changes, Redfield reserves the right to have all remaining grant funds immediately returned.

5. Any funds not used or committed for the specific purpose of the grant must be returned to Redfield unless otherwise authorized in writing.
6. Grant Recipient must provide a written report as soon as possible after close of the grant period describing conclusions, progress, and/or status of grant objectives including utilization of the grant funds to obtain the objective. ANY CONSIDERATION OF FUTURE FUNDING WILL BE CONTINGENT UPON RECEIPT OF SUCH WRITTEN REPORT.
7. Grant Recipient must advise Redfield with respect to any changes that occur in its management structure including change in its Executive Director or other management position that might be significant to its operation.
- 8. In keeping with Redfield's goals of responsible strategic philanthropy, your grant is eligible to be awarded over a three-year period, contingent on successful re-application each year and submission of a utilization report. Following this three-year cycle, a minimum one-year pause will be required before becoming eligible for funding again. This approach reflects best practices in philanthropy by encouraging grant sustainability, helping your organization broaden its circle of support, and providing opportunities for strengthening evaluation and reflection.**
