### SUMMARY

The Washoe Board of County Commissioners must approve amendments to the adopted fiscal year budget and direct Finance to make the appropriate budget amendments.

### PREVIOUS ACTION

On August 16, 2024, the District Health Officer executed this subaward amendment in the total amount of \$46,686.00 for the period of July 1, 2024 through June 30, 2025.

### BACKGROUND

Community and Clinical Health Services Immunization School Located Vaccination Clinic (SLVC) received funds for FY25 to work with Washoe County School District to review Title 1 schools who have lower vaccination rates, higher exemption rates, or may be in series for vaccination catch-up. The intent of this subgrant is to fund provider site visits specific to 317 Storage & Handling; and increase Vaccine Confidence and Outreach activities to under and uninsured populations within Northern Nevada Public Health.

The Subgrant provides funding for personnel, operating, other and indirect expenditures.
