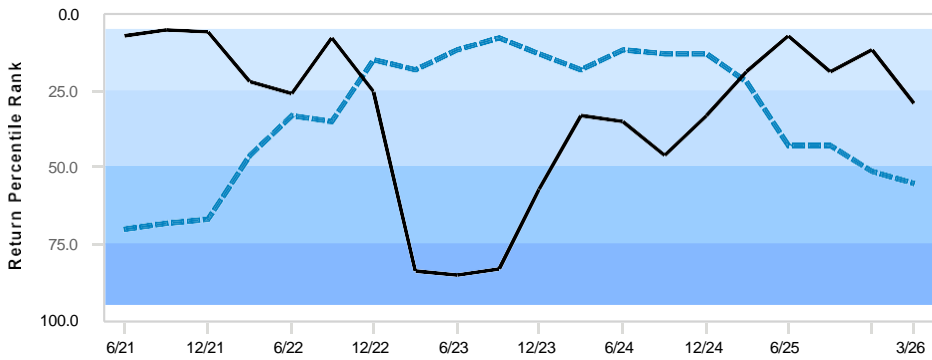

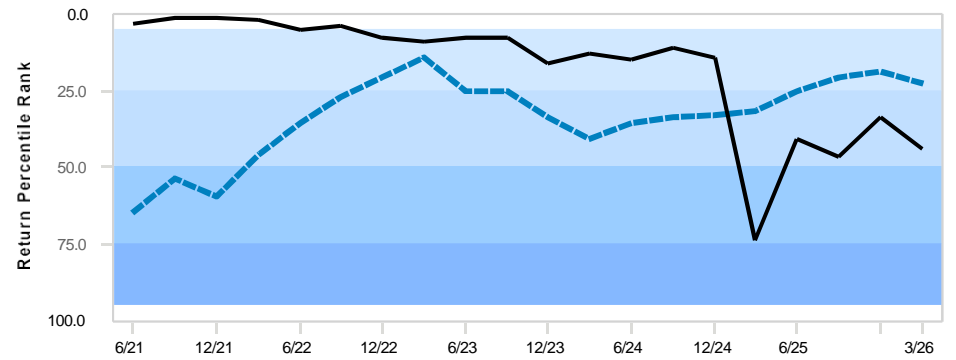


3 Years Rolling Percentile Ranking vs. Target-Date 2060



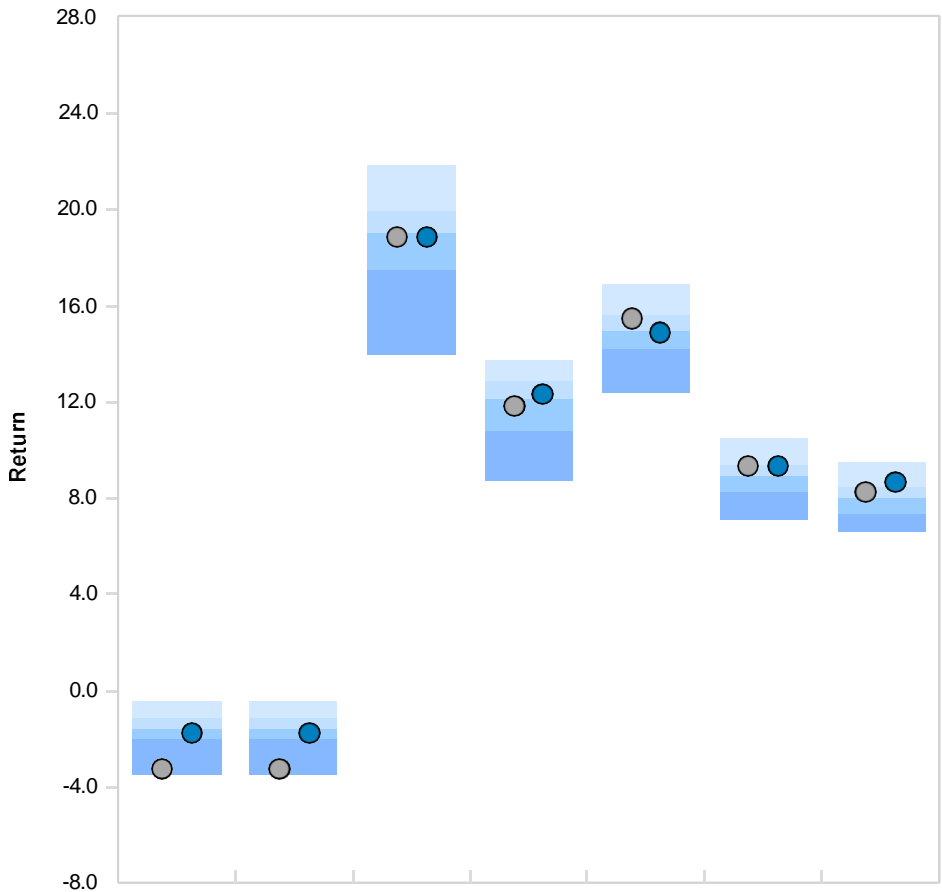

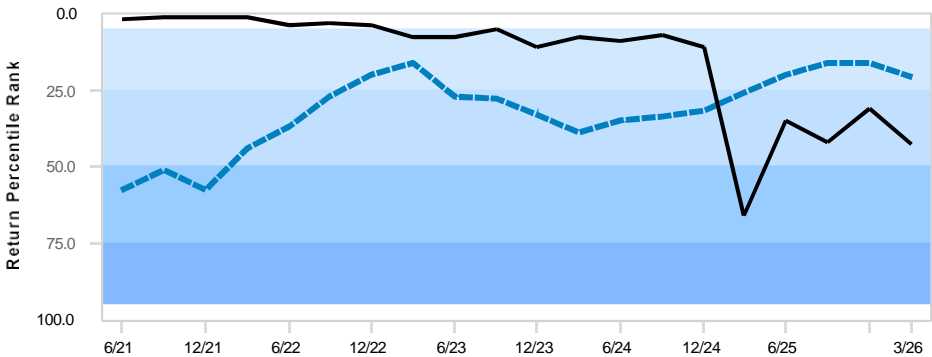

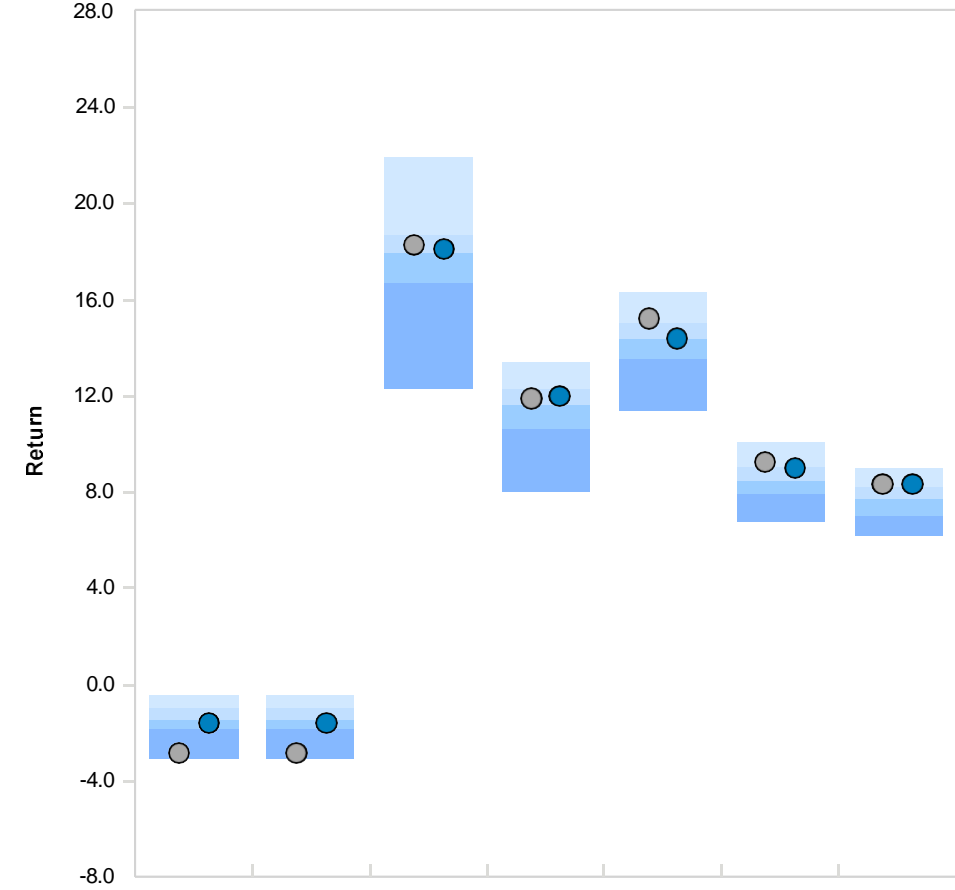
3 Years Rolling Percentile Ranking vs. Target-Date 2050

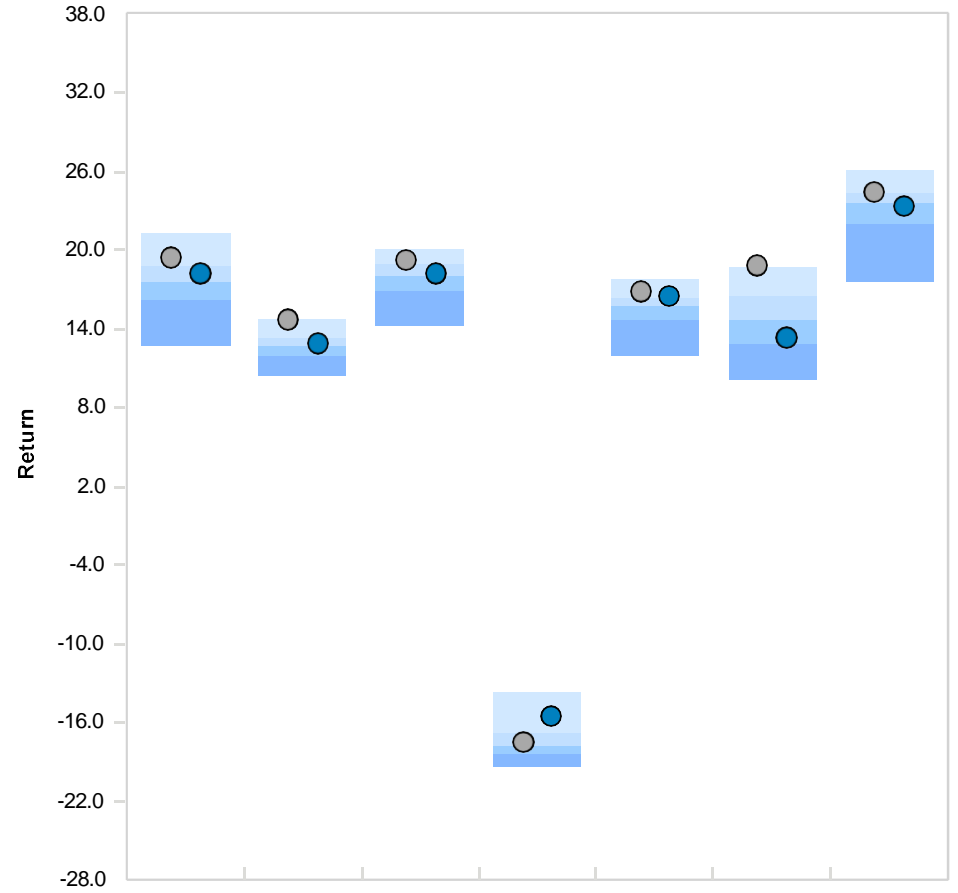

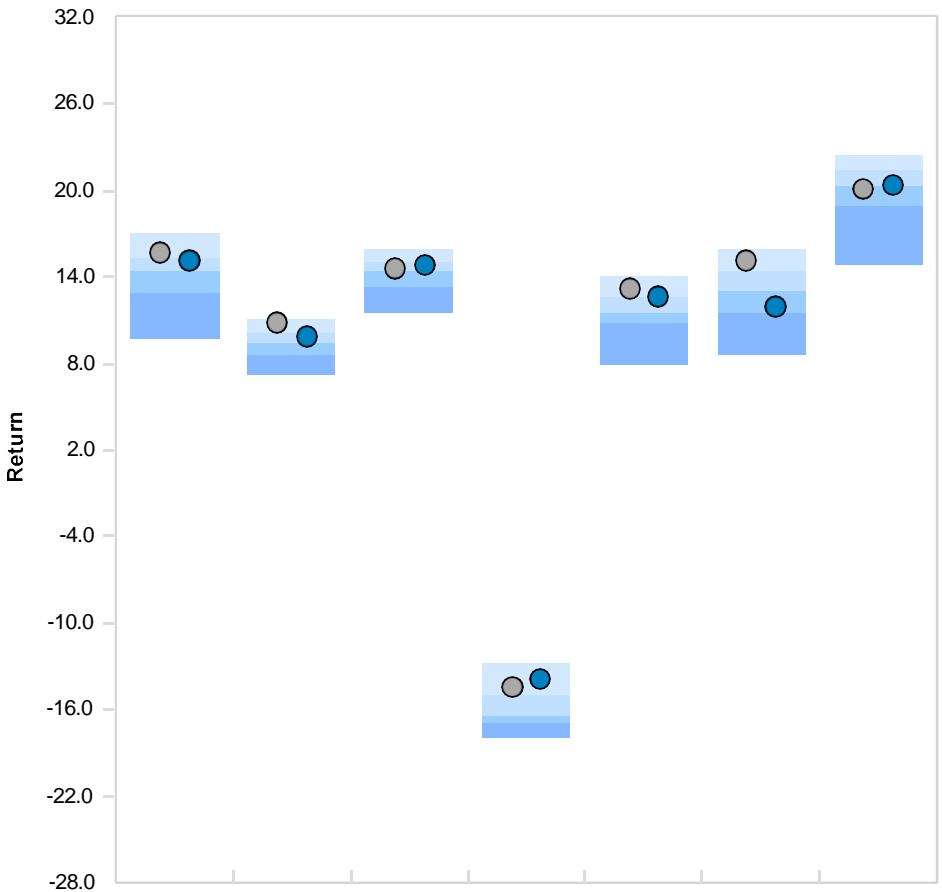

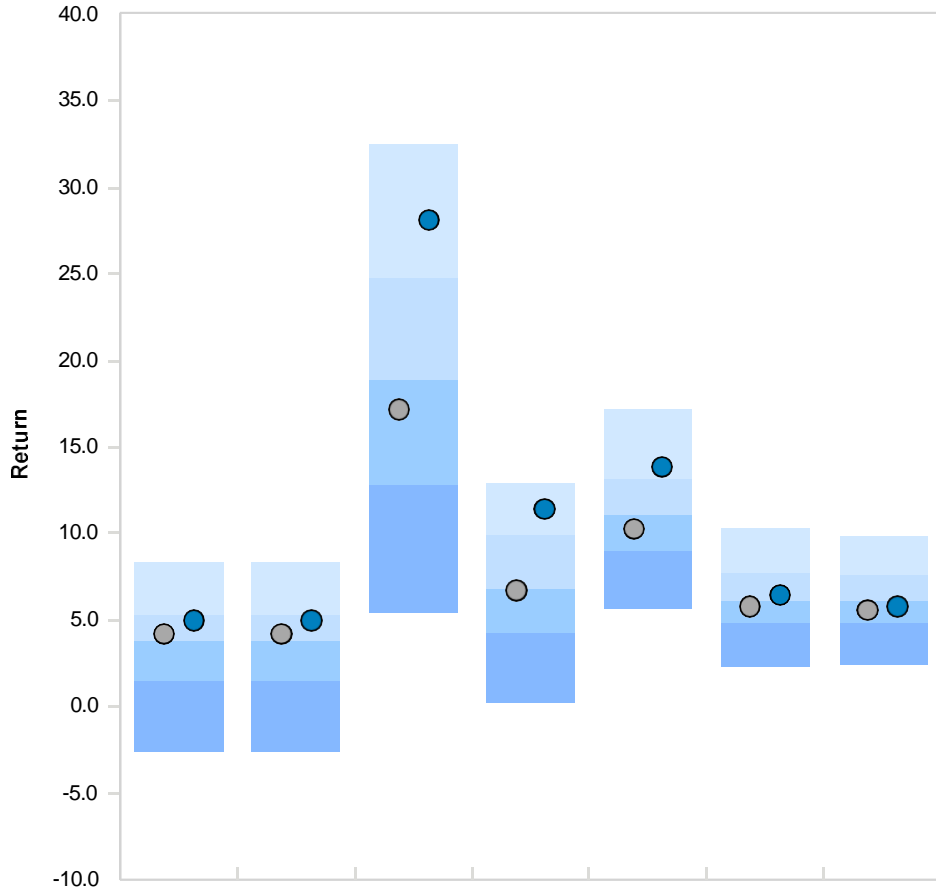
3 Years Rolling Percentile Ranking vs. Small Blend

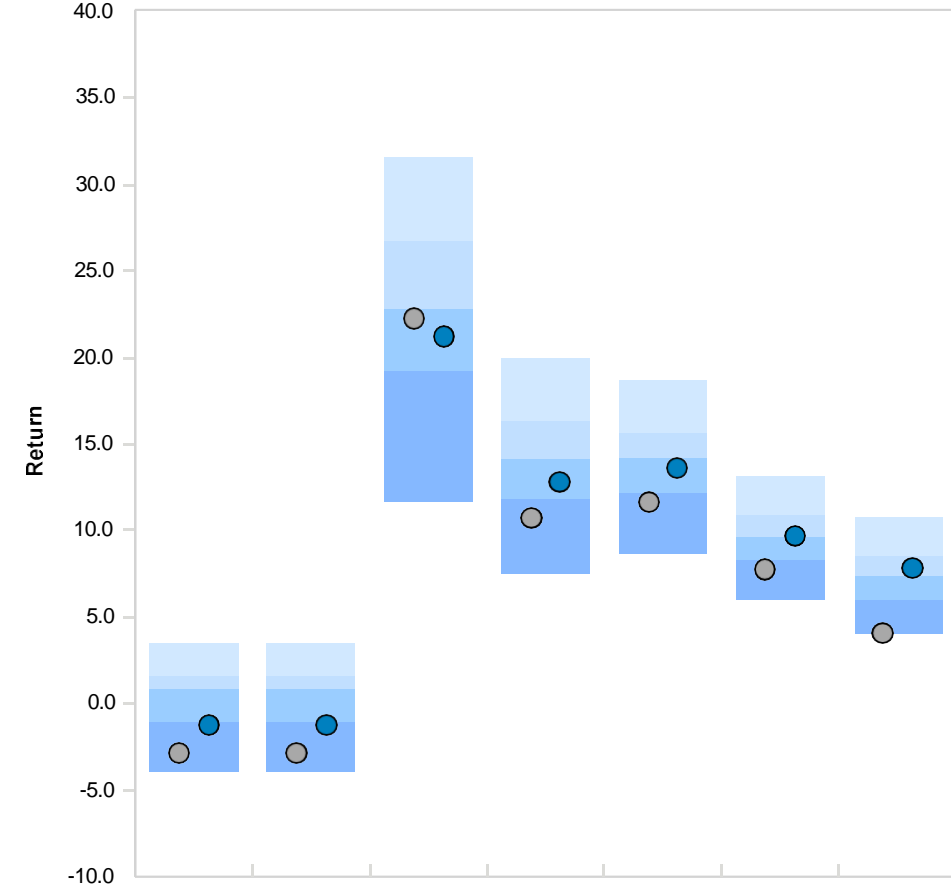
3 Years Rolling Percentile Ranking vs. Small Value

Active Return	- Arithmetic difference between the manager's performance and the designated benchmark return over a specified time period.
Alpha	- A measure of the difference between a portfolio's actual performance and its expected return based on its level of risk as determined by beta. It determines the portfolio's non-systemic return, or its historical performance not explained by movements of the market.

Up Market Capture	- The ratio of average portfolio performance over the designated benchmark during periods of positive returns. A higher value indicates better product performance.
