SUMMARY

Per NRS 293.2546 & 293.565, sample ballots are required to be prepared and mailed to each registered voter in the county, by mail, or electronic means if requested, before the period for early voting for any election begins. Based upon this requirement, a request for proposal (RFP 3166-22) was issued to provide the services for preparing, printing and mailing of sample ballots for the 2022 elections. Approval is recommended to authorize awarding RFP 3166-22 to Metro Mailing Service Inc., in the amount not to exceed \$500,000.

BACKGROUND

On October 26, 2021the Washoe County Purchasing Division released Request for Proposal #3166-22, Sample Ballot Mailing Services. One (1) respondent proposal was

received from Metro Mailing Service Inc. The Proposal was opened in the offices of the Washoe County Comptroller on November 19, 2021, and subsequently evaluated.

The proposed cost for bid item one (1) is \$0.0760 per sample ballot for approximately 315,000 ballots, not including postage and freight, for a total estimated cost of \$23,940. The proposed cost for bid item two (2) is \$0.2158 per sample ballot for approximately 340,000 sample ballots, not including postage and freight, for a total estimated cost of \$73,372.

FISCAL IMPACT

Should the Board approve this award, there is sufficient FY22 and FY23 budget authority to cover the proposed cost bid [\$500,000] within the Registrar of Voters (112) Elections Administration (C112210) Printing (710502).

RECOMMENDATION

Recommendation to Award Request for Proposal (RFP) No. 3166-22 for Sample Ballot Mailing Services for the 2022 elections to the lowest responsive and responsible bidder, Metro Mailing Service Inc., in the amount of \$500,000, and authorize the Purchasing and Contracts Manager to execute the contract.
