



**2025 HOT AUGUST NIGHTS CRUISE NIGHT
NON-PROFIT GROUP LETTER OF AGREEMENT**

This Agreement is entered into by and between the Washoe County Sheriff's Office CCP/CERT, ("The Group") and Hot August Nights, Inc., a Nevada not for Profit Corporation ("HAN"). It provides for specific obligations for both parties to perform, all of which are necessary items to ensure the success of HAN and its Cruise Night.

HAN is presenting The Group the opportunity to raise funds for its charitable activities. To that end, HAN is entering into this Agreement specifying that The Group named above will staff an Official HAN Cruise Night.

The term of this Agreement shall be for the 2025 HAN Main Event only.

SERVICES TO BE PROVIDED BY THE GROUP

1. Staff an Official HAN Cruise Night located in Downtown Reno, NV between the hours of 6:00 PM until 10:00 PM on the day and date specified here, August 6th – 9th, 2025.
2. The Group agrees to conduct themselves in a professional and courteous manner.
3. It is further agreed that The Group personnel will abide by the direction and supervision of the HAN Staff and Volunteer Management Team, i.e. the Car Events Assistant Chairman and Venue Manager.
4. The Group agrees to provide a minimum of 32 personnel (8 per evening for all 4 nights) to assist HAN Staff and Volunteer Management Team with traffic control and other related tasks at the Downtown Reno venue and with traffic and crowd control in and out of the designated Cruise Night area. The Group agrees that all club personnel working said venue must be at least 18 years of age or older.
5. The Group agrees to indemnify and hereby indemnifies and holds harmless HAN from all obligations, liabilities, harm, suits, damages, costs, or fees, including attorney's fees, arising from, or caused by all actions or omissions of or by The Group.



SERVICES TO BE PROVIDED BY HOT AUGUST NIGHTS

1. HAN will provide all equipment/supplies needed to run a safe and successful Cruise Night.
2. In consideration of the above, HAN agrees to pay The Group the total sum of Two Hundred Forty Eight Dollars (\$248.00) for each 4-hour shift worked by the entire 8-person group or a sum totaling Nine Hundred Ninety-Two Dollars for all 4 nights.
**** If the agreed upon quantity of people is exceeded, payment will be determined by a \$7.75/hour per person basis ****
3. Said total sum will be paid by HAN to The Group no later than September 15, 2025.

This Agreement constitutes the entire Agreement made, entered into, and signed by and between the parties hereto.
