PREVIOUS ACTION

Each year that Washoe County has received the GFOA Distinguished Budget Presentation Award, the Board of County Commissioners has acknowledged receipt of the recognition of the achievement.

BACKGROUND

The Government Finance Officers Association Budget Awards Program is designed to encourage governments to prepare budget documents of the highest quality to meet the needs of decision-makers and citizens. This award is the highest form of recognition in governmental budgeting. Its attainment represents a significant achievement for Washoe County and reflects our commitment to meeting the highest principles of governmental budgeting. In receiving the distinguished budget presentation award, Washoe County has met both guidelines established by the National Advisory Council on State and Local Budgeting and the GFOA's best practices on budgeting.

The guidelines are designed to assess how well Washoe County's budget serves as a policy document, a financial plan, an operations guide, and a communications device. This is the 23rd year that Washoe County has received this respected award.

This document award decision marks the first year in at least a decade that Washoe County has received special recognition for outstanding ratings in the two following categories: 1) Performance Measures and 2) Strategic Goals and Strategies. It also notably received the highest overall score by all raters, four points out of four, for the category of “Communications Device.”
