### **SUMMARY**

This item requests the Board to approve Resolutions and disburse district funds in the total amount of [\$25,000.00] for Commission District 1.

### **PREVIOUS ACTION**

On July 8, 2025 the Board of County Commissioners directed a [\$38,235.00] grant to Tahoe Transportation District -- a government entity -- to support and develop multi-modal transportation projects and transit services in the Washoe County portion of Lake Tahoe; and a [\$15,000.00] grant to Incline Village Crystal Bay Community and Business Association (IVCBA) -- a nonprofit organization created for religious, charitable or

educational purposes – for the purpose of supporting the Nevada Main Street program, an initiative focusing on downtown revitalization, and other community engagements; and a [\$10,000.00] grant to St. John’s Children’s Center – a nonprofit organization created for religious, charitable or educational purposes – for the purpose of installing a mandated back flow valve; and a [\$5,000.00] grant to Latino Arte -- a nonprofit organization created for religious, charitable or educational purposes – to support the Fiesta on Wells, a special event celebrating Hispanic Heritage Month; and a [\$2,850.00] grant to MidTown Reno Foundation – a nonprofit organization created for religious, charitable or educational purposes – to support MidTown Snowflakes, an annual winter tradition lighting up MidTown; and a [\$2,020.00] grant to Washoe County Community Services Department (CSD) Regional Parks and Open Space – a government entity – to cover park fees at the Hawkins Amphitheater for Gospel Fest; and a [\$1,895.00] grant to Word of Life Ministries – a nonprofit organization created for religious, charitable or educational purposes – to support the audio equipment provided by Starsound Audio, Inc. at Gospel Fest 2025.

### **BACKGROUND**

Modification of guidelines and adoption of resolution for County Commission District Special Funding on February 10, 2015, created Commission District Special Funds for each Commission District. On May 20, 2025, the Board of County Commissioners approved the 2025-2026 fiscal year budget with special district funds allocated per Commission District in the amount of \$100,000.00. The monies appropriated are to support needs for all Washoe County residents.

Funds appropriated through the Commission District Special Funds must provide substantial benefit to the inhabitants of the County. The recipient must be a non-profit organization, created for religious, charitable, or educational purposes, or a government entity. Funds shall not provide any personal or private benefit for the Commissioners, directly or indirectly benefit any campaign efforts by a commissioner, violate Ethics in Government law, or be used to purchase tickets to special events.

Commissioner Hill has elected to support the following organization in fiscal year 2025-2026:

- A [\$12,500.00] grant to Truckee North Tahoe/Transportation Management Association (TNT/TMA) -- a government entity -- to support North Lake Tahoe Express Airport Shuttle (NLTE).
- A [\$10,000.00] grant to Tahoe Prosperity Center – a nonprofit organization created for religious, charitable or educational purposes – for the purpose of supporting the 2025 Envision Tahoe Venture Summit.
- A [\$2,500.00] grant to the Nevada Peer Support Network (NPSN) – a nonprofit organization created for religious, charitable or educational purposes – for the purpose of providing resources and support to our first responders and hospital health care professionals.

### **FISCAL IMPACT**

Sufficient FY25-26 budget authority exists within the Cost Center District 1 Constituents (C100101) and account Payments to other Agencies (710400). This action requests

approval and distribution of a [total of \$25,000.00] to Truckee North Tahoe/Transportation Management Association, Tahoe Prosperity Center, and Nevada Peer Support Network.

Expense Disbursements are required as follows:

- Truckee North Tahoe/Transportation Association: \$12,500.00
- Tahoe Prosperity Center: \$10,000.00
- Nevada Peer Support Network: \$2,500.00
