This item requests the Board to approve Resolutions and disburse district funds in the total amount of [\$63,235.00] for Commission District 1.

PREVIOUS ACTION

No previous action in Fiscal Year 2024-2025.

BACKGROUND

Modification of guidelines and adoption of resolution for County Commission District Special Funding on February 10, 2015, created Commission District Special Funds for each Commission District. On May 21, 2024, the Board of County Commissioners approved the 2024-2025 fiscal year budget with special district funds allocated per Commission District in the amount of \$100,000.00. The monies appropriated are to support needs for all Washoe County residents.

Funds appropriated through the Commission District Special Funds must provide substantial benefit to the inhabitants of the County. The recipient must be a non-profit organization, created for religious, charitable, or educational purposes, or a government entity. Funds shall not provide any personal or private benefit for the Commissioners, directly or indirectly benefit any campaign efforts by a commissioner, violate Ethics in Government law, or be used to purchase tickets to special events.

Commissioner Hill has elected to support the following organization in fiscal year 2024-2025:

- A [\$25,000.00] grant to TNT/TMA -- a government entity -- to support NLTE.
- A [\$20,000.00] grant to Tahoe Fund -- a nonprofit organization created for charitable, religious, or educational purposes -- for the educational take care of Tahoe winter and summer billboards.
- A [\$10,000.00] grant to Tahoe Fund -- a nonprofit organization created for religious, charitable or educational purposes -- to support the Lake Tahoe Destination Stewardship Council.
- A [\$5,000.00] grant to Washoe County Community Services Department – a government entity-- to support Clean Tahoe professional fees.
- A [\$2,235.00] grant to Community Services Department: Parks and Open Space government entity to cover the park fees at the Hawkins Amphitheater for Gospel fest.
- A [\$1,000.00] grant to Education Renaissance of Nevada Initiative -- a nonprofit organization created for charitable, religious, or educational purposes -- to support the spellbinders festival.

FISCAL IMPACT

Sufficient FY24-25 budget authority exists within the Cost Center District 1 Constituents (C100101) and account Payments to other Agencies (710400). This action requests approval and distribution of a [total of \$63,235.00] to.
