### **Major Incident Summary for July 2025**

**July 1:** Barron Fire; Reno and TMFR Jurisdiction. 290 Acres, no structure loss.  
**July 7:** Structure fire on Pegasus Drive, fire crews met by a combative resident, later detained by WCSO, total loss of structure  
**July 14:** Van Fire, north of Sun Valley at 41 acres, no structure loss.  
**July 15:** Ironwood Fire in Palomino Valley at 44 acres, no structure loss.  
**July 22:** Charlene Drive structure fire in Lemmon Valley, three people displaced, total loss of structure.  
**July 26:** Chickadee Fire between Hungry Valley and Lemmon Valley at approx. 15 acres, no structure loss.  
**July 29:** Brush fire between two structures on Hawk St. in Washoe Valley. Structures saved with minor damage.

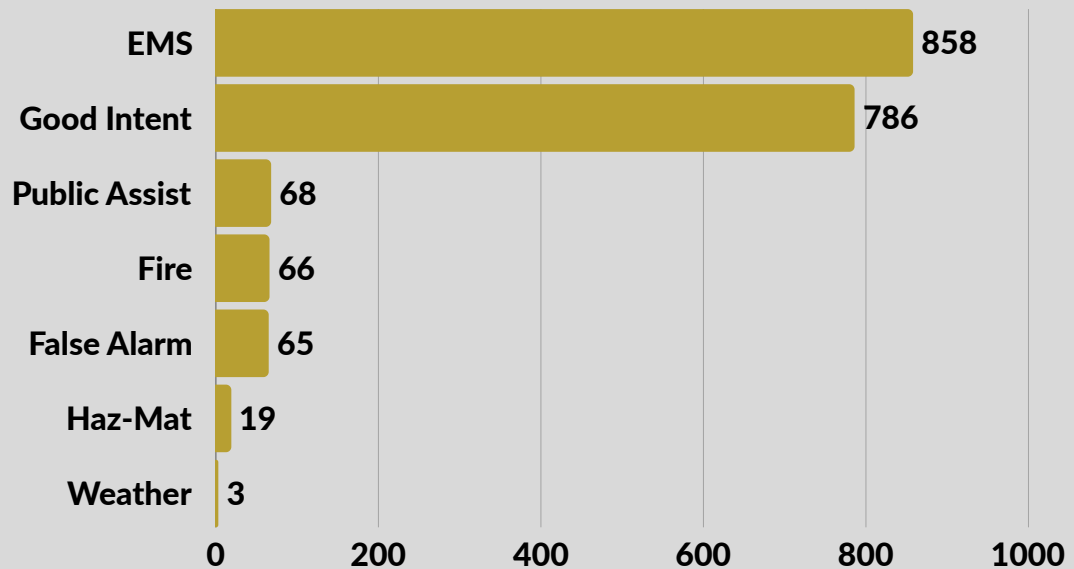




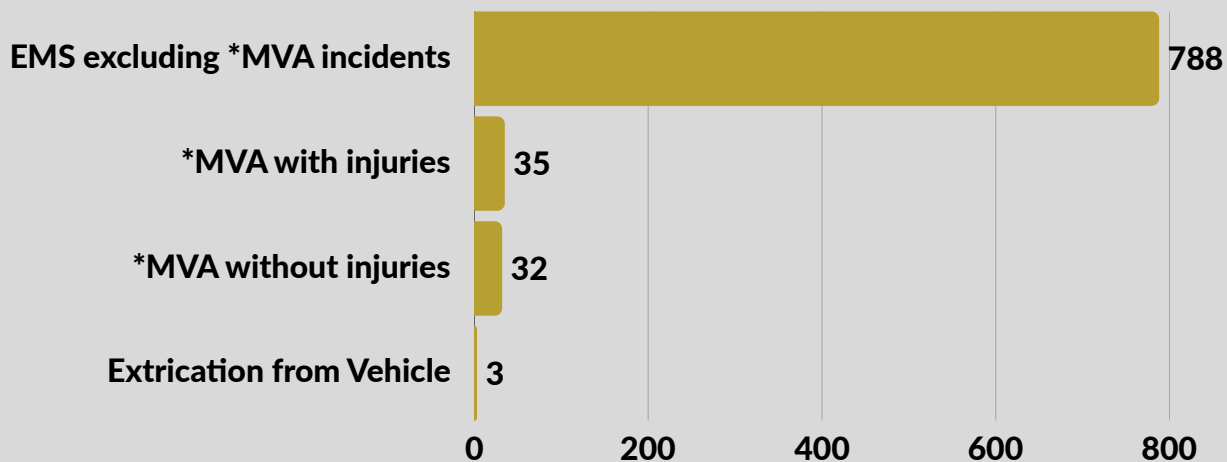

### Incident Total for July 2025: 1,865



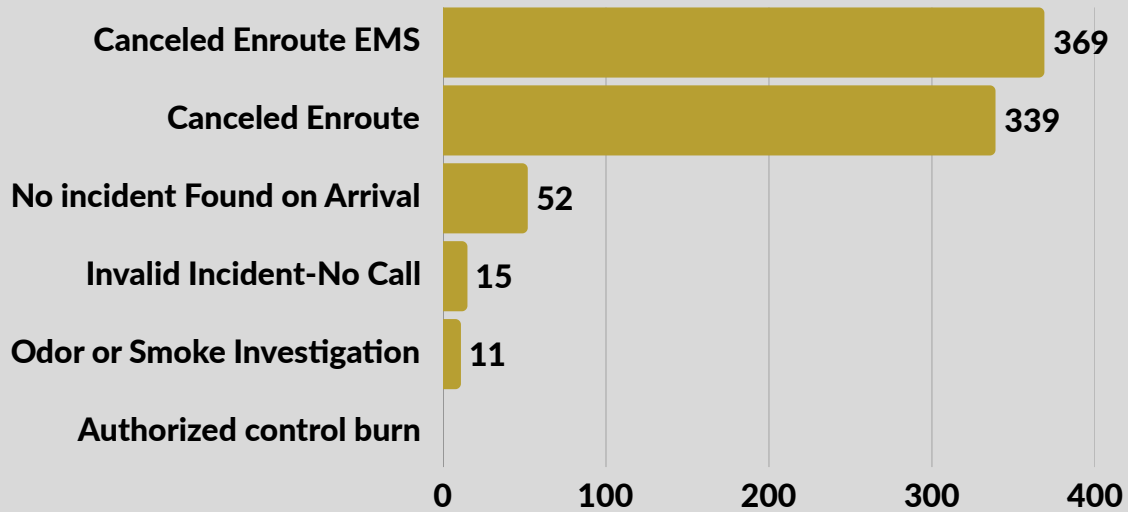

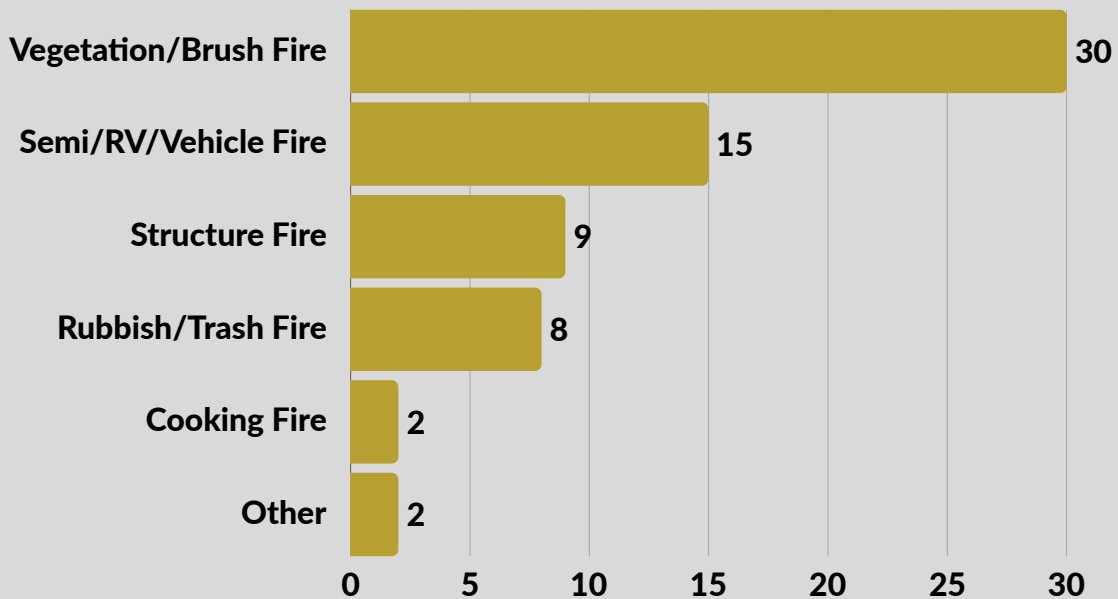

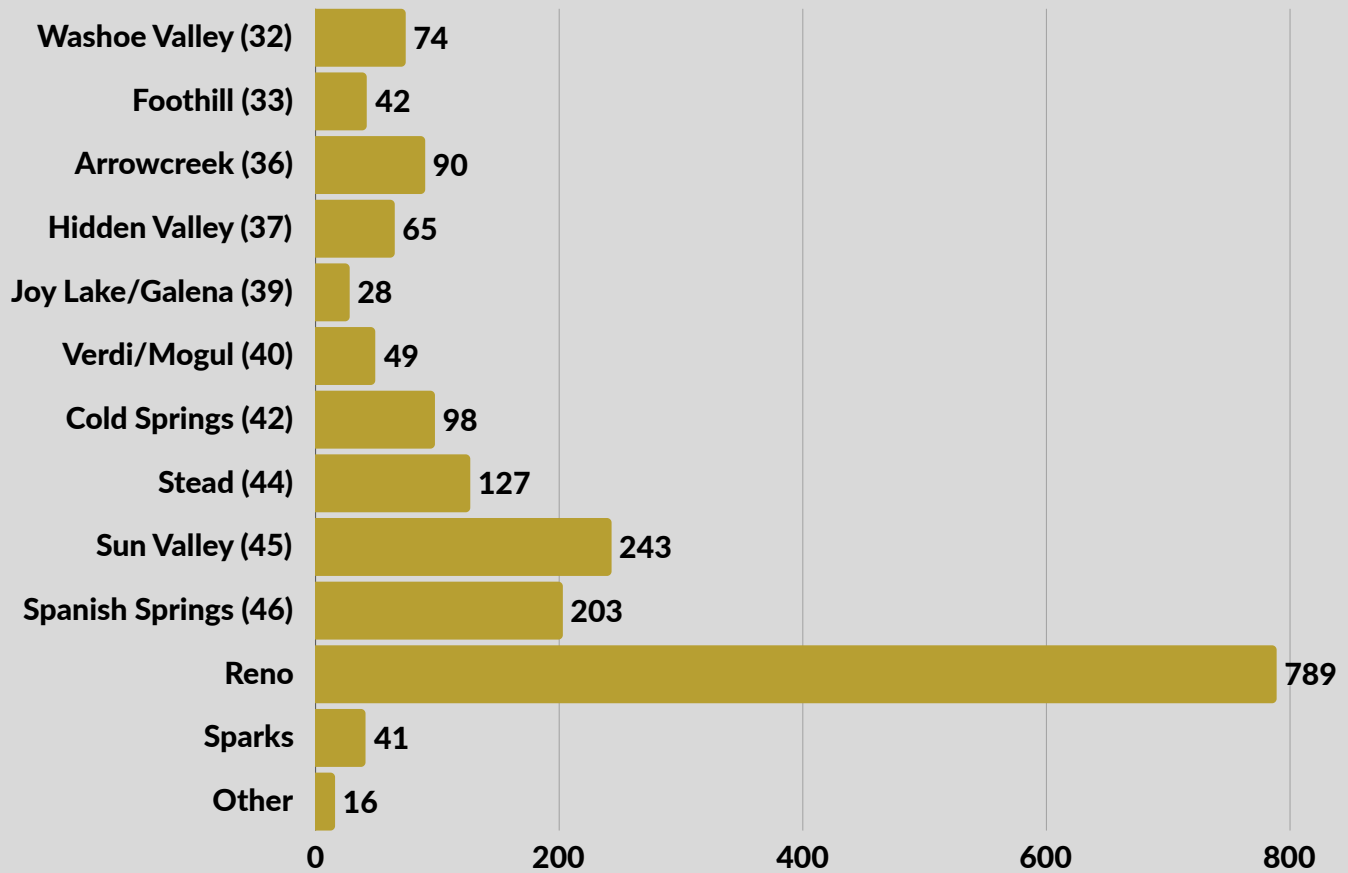

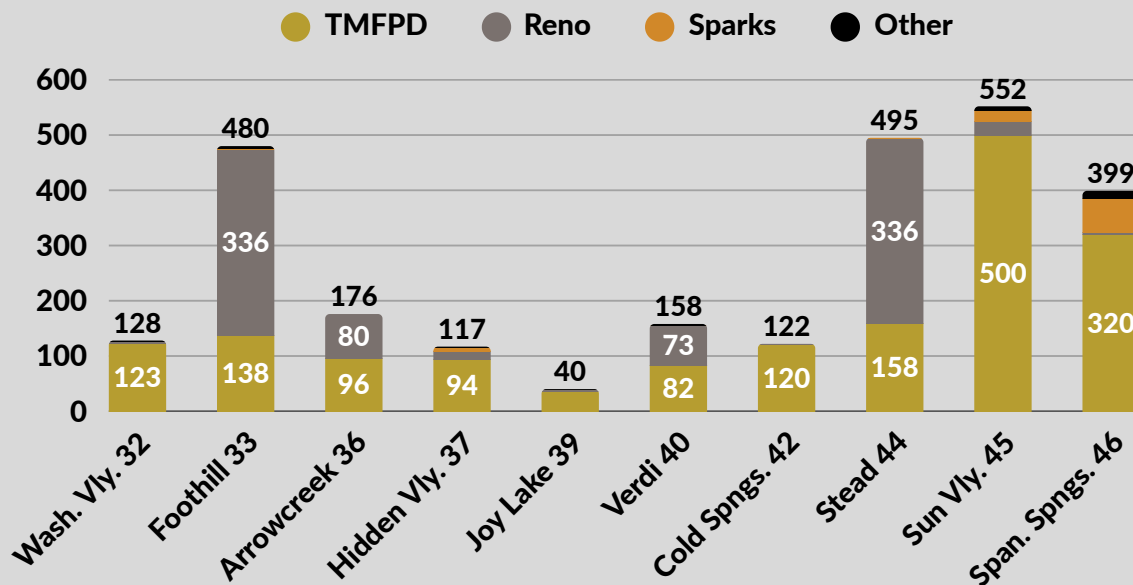


## July 2025 TM Unit Responses

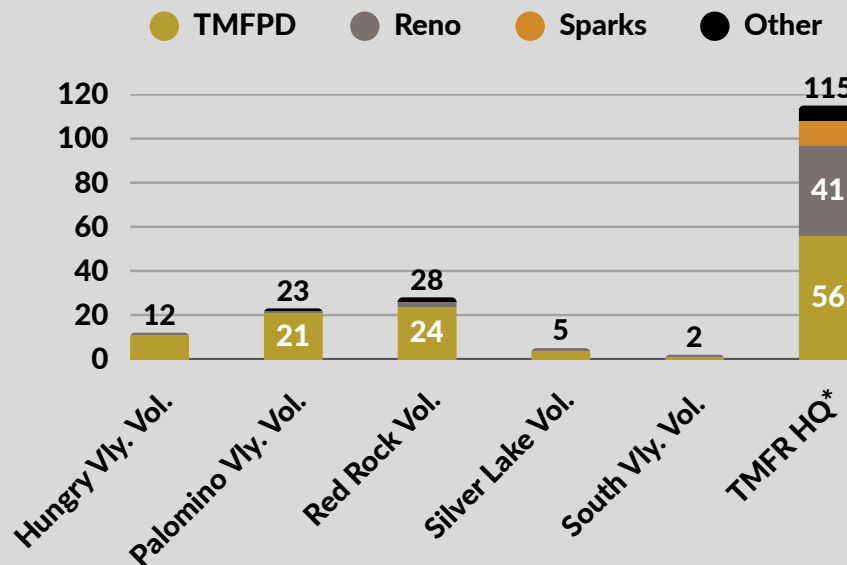
Some incidents require more than one resource to respond. The information below reflects the number of unit responses.

\*HQ includes Wildland Division, Chief officers, and other units not assigned to a station.

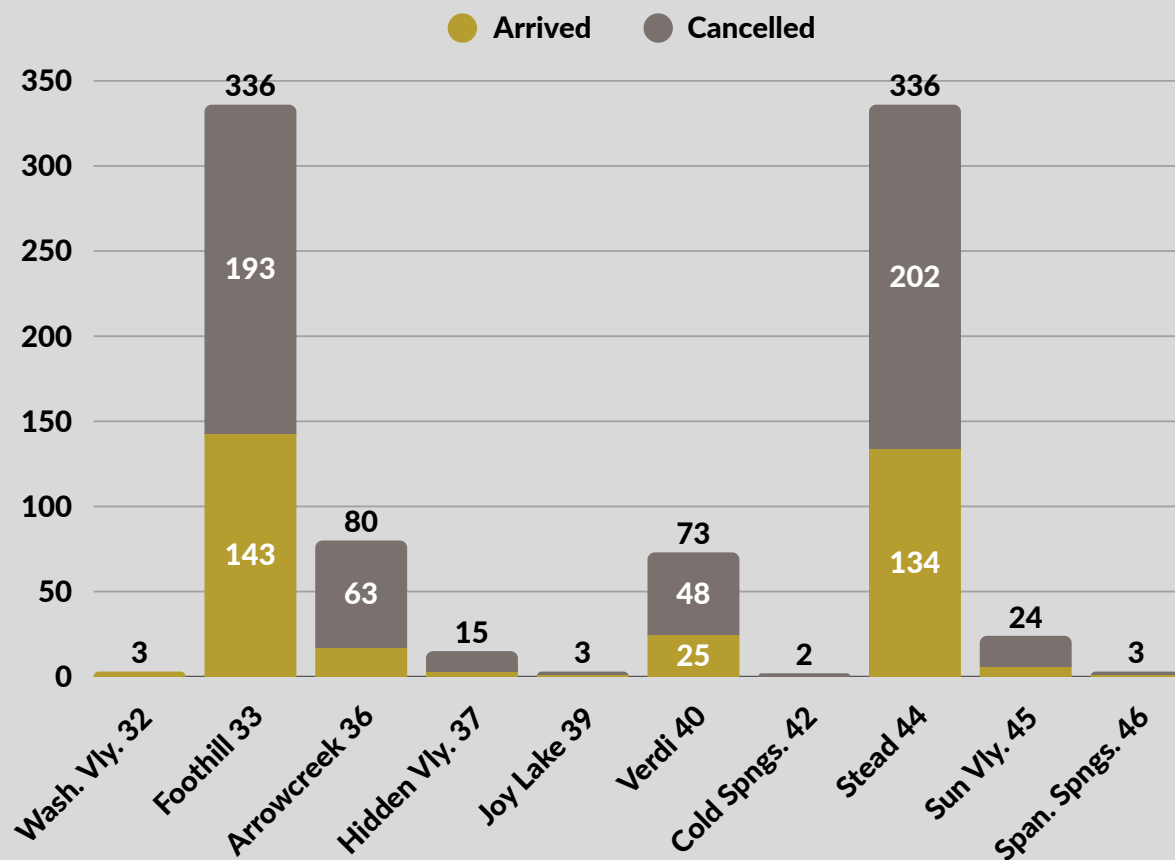

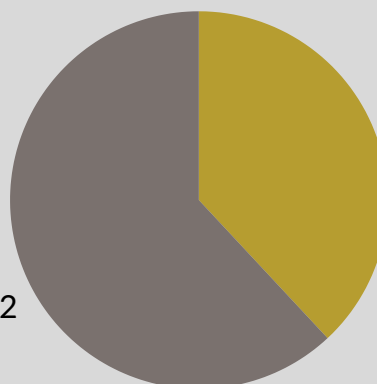

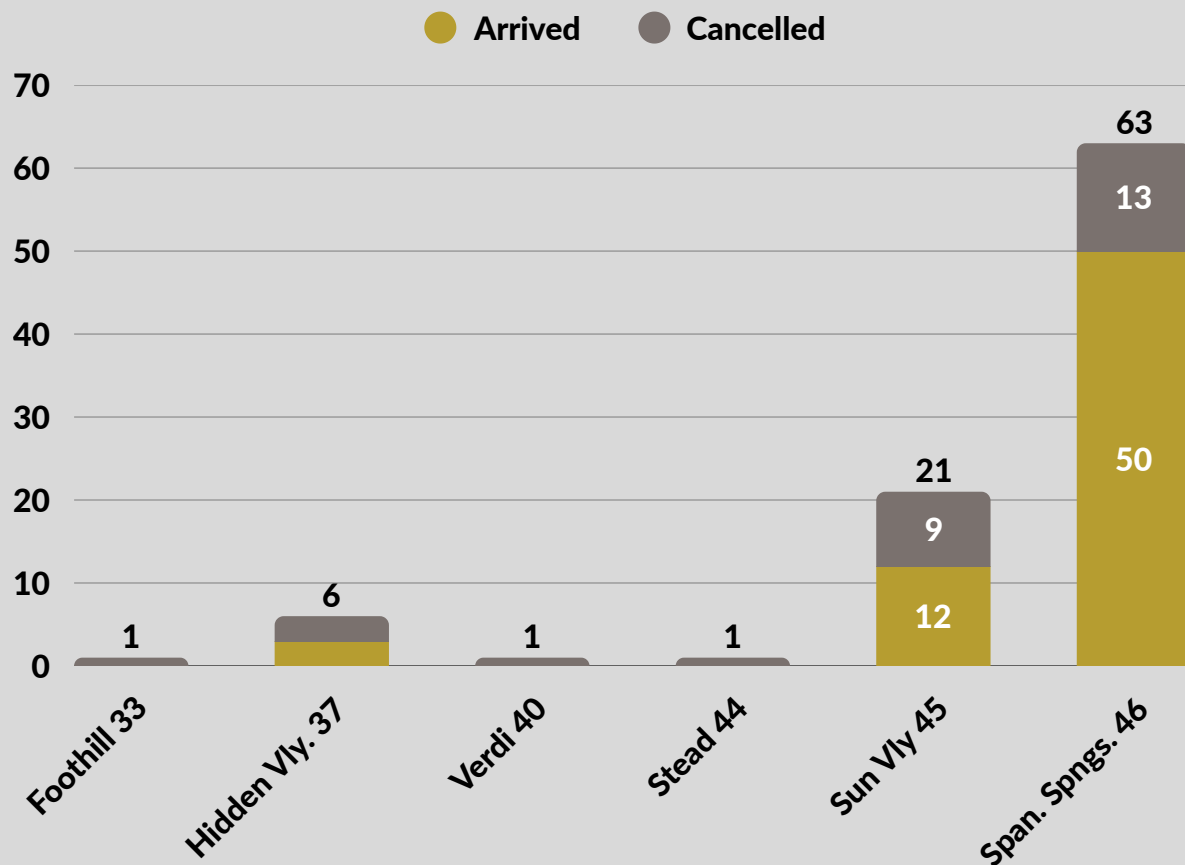

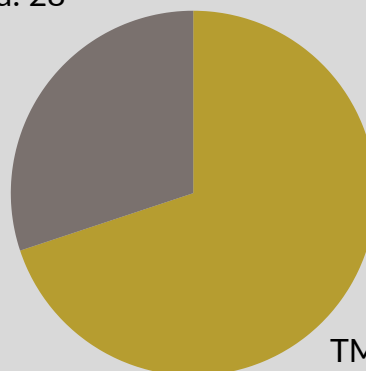


## July 2025 Mutual and Automatic Aid Provided - Career Stations

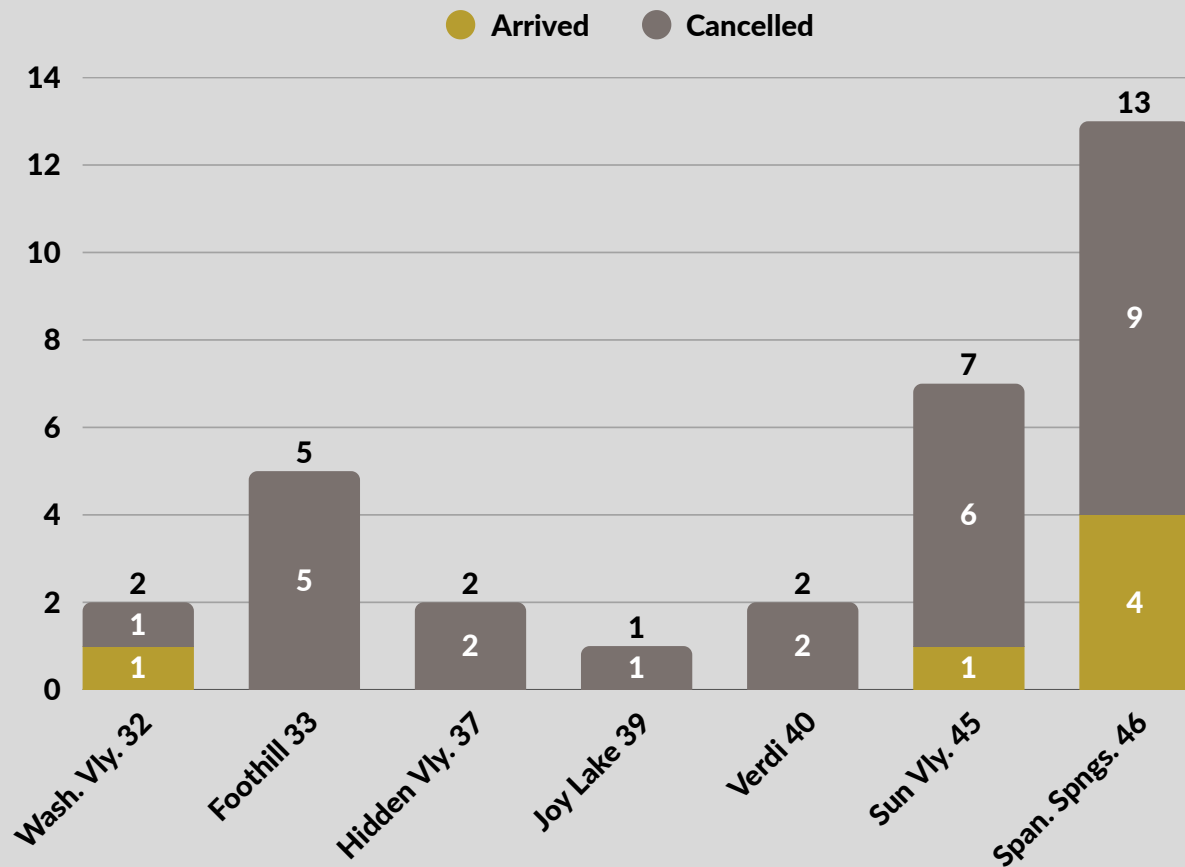

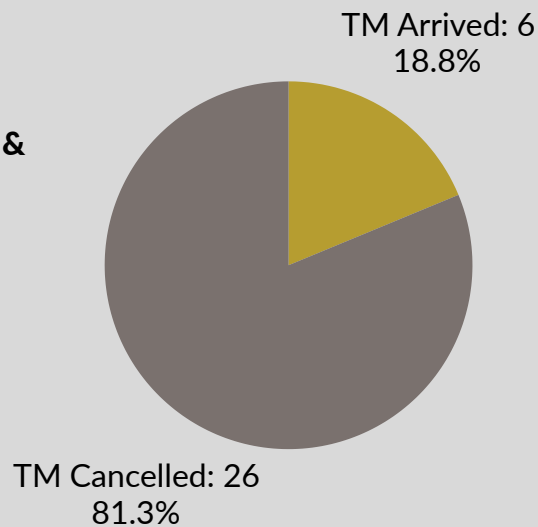

### TM Unit Arrival - Other: 32



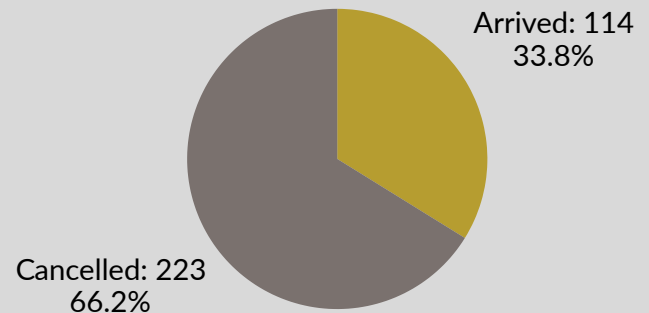
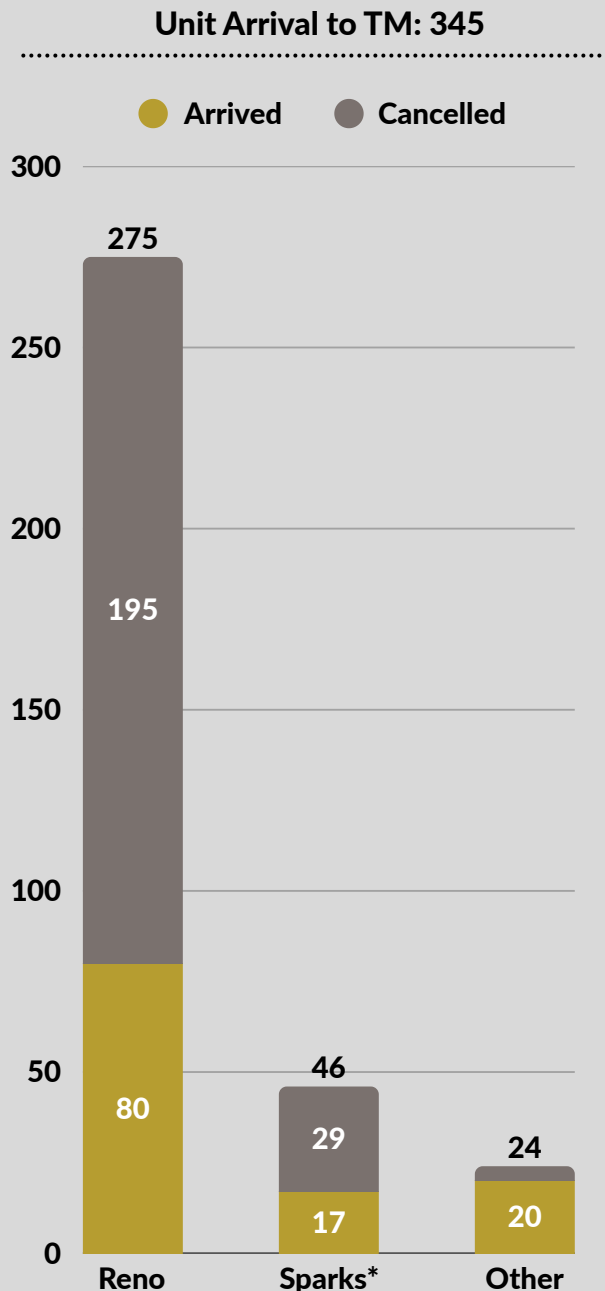
