

Dates of Franchise Meetings

This document provides a summary of meetings in which the EMS Franchise Agreement was discussed, reviewed, or advanced through coordination and implementation efforts. Meetings are identified as Joint Advisory Committee (JAC) meetings or non-JAC engagements.

JAC meetings serve as a primary forum for structured discussion and oversight related to the Franchise. Core invitees for Franchise-related JAC discussions include representatives from Sparks Fire Department, Reno Fire Department, Truckee Meadows Fire Protection District (TMFPD), REMSA Health, and Northern Nevada Public Health (NNPH).

In addition to JAC meetings, this summary includes coordination meetings with District Board of Health (DBOH) members, as well as engagements with city and county leadership. These meetings varied in purpose, duration, and level of formality, ranging from operational coordination to executive-level discussions and policy alignment.

Collectively, these engagements reflect ongoing oversight, interagency collaboration, and continued progress toward implementation and operational alignment of the EMS Franchise Agreement.
